Amendment to Budget Bill Item 7760-005-0666, Support, Department of General Services

It is requested that provisional language be added to Item 7760-005-0666 to address the operation of the proposed funding mechanism for the Zero Emission Vehicle Project proposal. The purpose of Provision 1 is to ensure that non-state funding sources available for this purpose have been maximized. The purpose of Provision 2 is to provide additional resources to departments whose main support comes from funds other than the General Fund, either in total or in part. Suggested provisional language is attached (see Attachment 1).

Add the following provisions to Item 7760-005-0666:

1. The amount appropriated in this item shall be used for engineering assessments and electric vehicle charging infrastructure at state facilities. Prior to the expenditure of state funds, the Department of General Services shall certify that it has maximized available funding from non-state sources for this purpose.
2. Upon presentation of project cost information by the Department of General Services, the Director of Finance may augment any non-General Fund item of appropriation by an amount sufficient to reimburse the Department for the activities specified in Provision 1.
