# Amendment to Budget Bill Item 8120-002-0903, Support, and Item 8120-102-0903, Local Assistance, and Trailer Bill Language, Commission on Peace Officer Standards and Training

It is requested that Item 8120-002-0903 be increased by \$2,860,000 and Item 8120-102-0903 be increased by \$546,000 to withdraw the Governor's Budget reduction, which would have decreased the number of Sherman Block Supervisory Leadership Institute, Robert Presley Institute of Criminal Investigation, and Command College training courses.

It is also requested that trailer bill language be added to amend the Penal Code and the Health and Safety Code to replace references to the Peace Officers' Training Fund, which is no longer used by the Commission on Peace Officer Standards and Training, with the State Penalty Fund (see Attachment 1).

### SEC 1. Penal Code Section 13523 is amended to read:

**13523.** (a) The commission shall annually allocate and the State Treasurer shall periodically pay from the Peace Officers' Training FundState Penalty Fund, at intervals specified by the commission, to each city, county, district, or joint powers agency, that has applied and qualified for aid pursuant to this chapter an amount determined by the commission pursuant to standards set forth in its regulations. The commission shall grant aid only on a basis that is equally proportionate among cities, counties, districts, and joint powers agencies. State aid shall only be provided for training expenses of full-time regularly paid employees, as defined by the commission, of eligible agencies from cities, counties, districts, or joint powers agencies.

(b) In no event shall any allocation be made to any city, county, district, or joint power agency that is not adhering to the standards established by the commission as applicable to that city, county, district, or joint powers agency.

(c) (1) The commission shall annually allocate and the State Treasurer shall periodically pay from the Peace Officers' Training Fund, at intervals specified by the commission, to each city, county, district, or joint powers agency, that has applied and qualified for aid pursuant to this chapter an amount determined by the commission pursuant to standards set forth in its regulations. The commission shall grant aid only on a basis that is equally proportionate among cities, counties, districts, and joint powers agencies. State aid shall only be provided for training expenses of full-time regularly paid employees, as defined by the commission, of eligible agencies from cities, counties, districts, or joint powers agencies.

(2) This subdivision shall be repealed on July 1, 2019.

# SEC 2. Penal Code Section 832.6 is amended to read:

**832.6.** (a) Every person deputized or appointed, as described in subdivision (a) of Section 830.6, shall have the powers of a peace officer only when the person is any of the following:

(1) A level I reserve officer deputized or appointed pursuant to paragraph (1) or (2) of subdivision (a) or subdivision (b) of Section 830.6 and assigned to the prevention and detection of crime and the general enforcement of the laws of this state, whether or not working alone, and the person has completed the basic training course for deputy sheriffs and police officers prescribed by the Commission on Peace Officer Standards and Training. For level I reserve officers appointed prior to January 1, 1997, the basic training requirement shall be the course that was prescribed at the time of their appointment. Reserve officers appointed pursuant to this paragraph shall satisfy the continuing professional training requirement prescribed by the commission.

(2) A level II reserve officer assigned to the prevention and detection of crime and the general enforcement of the laws of this state while under the immediate supervision of a peace officer who has completed the basic training course for deputy sheriffs and police officers prescribed by the Commission on Peace Officer Standards and Training, and the level II reserve officer has completed the course required by Section 832 and any other training prescribed by the commission.

Level II reserve officers appointed pursuant to this paragraph may be assigned, without immediate supervision, to those limited duties that are authorized for level III reserve officers

pursuant to paragraph (3). Reserve officers appointed pursuant to this paragraph shall satisfy the continuing professional training requirement prescribed by the commission.

(3) Level III reserve officers may be deployed and are authorized only to carry out limited support duties not requiring general law enforcement powers in their routine performance. Those limited duties shall include traffic control, security at parades and sporting events, report taking, evidence transportation, parking enforcement, and other duties that are not likely to result in physical arrests. Level III reserve officers while assigned these duties shall be supervised in the accessible vicinity by a level I reserve officer or a full-time, regular peace officer employed by a law enforcement agency authorized to have reserve officers. Level III reserve officers without immediate supervision. Those persons shall have completed the training required under Section 832 and any other training prescribed by the commission for those persons.

(4) A person assigned to the prevention and detection of a particular crime or crimes or to the detection or apprehension of a particular individual or individuals while working under the supervision of a California peace officer in a county adjacent to the state border who possesses a basic certificate issued by the Commission on Peace Officer Standards and Training, and the person is a law enforcement officer who is regularly employed by a local or state law enforcement agency in an adjoining state and has completed the basic training required for peace officers in his or her state.

(5) For purposes of this section, a reserve officer who has previously satisfied the training requirements pursuant to this section, and has served as a level I or II reserve officer within the

three-year period prior to the date of a new appointment shall be deemed to remain qualified as to the Commission on Peace Officer Standards and Training requirements if that reserve officer accepts a new appointment at the same or lower level with another law enforcement agency. If the reserve officer has more than a three-year break in service, he or she shall satisfy current training requirements.

This training shall fully satisfy any other training requirements required by law, including those specified in Section 832.

In no case shall a peace officer of an adjoining state provide services within a California jurisdiction during any period in which the regular law enforcement agency of the jurisdiction is involved in a labor dispute.

(b) Notwithstanding subdivision (a), a person who is issued a level I reserve officer certificate before January 1, 1981, shall have the full powers and duties of a peace officer as provided by Section 830.1 if so designated by local ordinance or, if the local agency is not authorized to act by ordinance, by resolution, either individually or by class, if the appointing authority determines the person is qualified to perform general law enforcement duties by reason of the person's training and experience. Persons who were qualified to be issued the level I reserve officer certificate before January 1, 1981, and who state in writing under penalty of perjury that they applied for but were not issued the certificate before January 1, 1984. For purposes of this section, certificates so issued shall be deemed to have the full force and effect of any level I reserve officer certificate issued prior to January 1, 1981.

(c) In carrying out this section, the commission:

(1) May use proficiency testing to satisfy reserve training standards.

(2) Shall provide for convenient training to remote areas in the state.

(3) Shall establish a professional certificate for reserve officers as defined in paragraph (1) of subdivision (a) and may establish a professional certificate for reserve officers as defined in

paragraphs (2) and (3) of subdivision (a).

(4) Shall facilitate the voluntary transition of reserve officers to regular officers with no unnecessary redundancy between the training required for level I and level II reserve officers.

(d) In carrying out paragraphs (1) and (3) of subdivision (c), the commission may establish and levy appropriate fees, provided the fees do not exceed the cost for administering the respective services. These fees shall be deposited in the Peace Officers' Training FundState Penalty Fund established by Section 135201464.

(e) The commission shall include an amount in its annual budget request to carry out this section.

### SEC 3. Health and Safety Code 103680 is amended to read:

**103680.** (a) Effective January 1, 1991, an additional fee of three dollars (\$3) for issuance of a permit for disposition of human remains pursuant to Section 103675 shall be payable to the local registrar of births and deaths by the applicant for the permit. This amount shall be exempt from any adjustment made pursuant to Section 100430.

(b) Notwithstanding any other provision of law, the local registrar of births and deaths shall pay into the Peace Officers' Training FundState Penalty Fund, by the 10th of the month following the end of each calendar quarter one dollar (\$1) of the fee collected pursuant to subdivision (a) for the training of peace officer members of county coroners' offices. The remaining funds collected pursuant to subdivision (a) shall be paid into the county treasury to be expended for indigent burial.

### Amendment to Budget Bill Items 8570-001-0001 and 8570-101-0001, and Addition of Item 8570-490, Support and Local Assistance, California Department of Food and Agriculture

**Nutria Detection and Survey**—It is requested that Item 8570-001-0001 be increased by \$400,000 and 1 position on a two-year limited-term basis to provide resources for additional survey and detection activities in support of the California Department of Fish and Wildlife's nutria eradication efforts. These activities are necessary to help determine the extent of this pest's infestation and to help inform the California Department of Fish and Wildlife's nutria eradication efforts.

**San Joaquin Valley Grant**—It is requested that Item 8570-101-0001 be increased by \$500,000 on a one-time basis to support the California Partnership for the San Joaquin Valley during its development of a sustainable funding plan to cover its administrative costs, which will enable the Partnership to continue implementation of its Strategic Plan. The Partnership is a public-private partnership focused on improving economic vitality and quality of life in the San Joaquin Valley, including a number of projects in the agricultural sector.

It is also requested that the following provision be added to Item 8570-101-0001 as follows to authorize the California Department of Food and Agriculture to provide this funding to the Partnership:

1. Of the amount appropriated in this item, \$500,000 shall be provided to the California Partnership for the San Joaquin Valley for its administrative costs.

**Greenhouse Gas Reduction Fund Reappropriation**—It is requested that Item 8570-490 be added to reappropriate a portion of administrative funding for the State Water Efficiency and Enhancement Program, from the California Department of Food and Agriculture's 2016-17 Greenhouse Gas Reduction Fund appropriation, which expires on June 30, 2018 (see Attachment 1). This funding is necessary to manage and close out awarded projects that will be completed in fiscal year 2018-19, and to audit completed projects.

# Amendment to Budget Bill Item 8660-001-0471, Support, and Item 8660-101-0471, Local Assistance, California Public Utilities Commission

**Universal Lifeline Telephone Service Program (California LifeLine Program)**—It is requested that Item 8660-001-0471 be decreased by \$1,161,000 to reflect a decrease in the projected number of application reviews and renewals the California LifeLine Program Third Party Administrator will perform in fiscal year 2018-19.

It is also requested that Item 8660-101-0471 be decreased by \$37,699,000 to reflect an estimated decrease in projected local assistance claims.

Both of the decreases are due to lower projected new enrollment and renewal figures for the California LifeLine Program. Changes in federal Lifeline Program rules also increased the number of disconnections from the California LifeLine Program, resulting in a projected reduction in local assistance claims.

# Amendment to Budget Bill Item 8885-295-0001, Local Assistance, Commission on State Mandates

It is requested that Item 8885-295-0001 be increased by \$312,208,000 to pay down a long-standing state liability associated with 14 expired or repealed state mandates, including the interest owed on those claims. Of the amount requested, \$280,541,000 is owed as a result of mandates associated with mental health services and local agencies are strongly encouraged to use new funds toward these services.

It is also requested that provisional language be added to authorize the Department of Finance, after providing 30 days' notice to the Joint Legislative Budget Committee, to order the State Controller to augment the amount appropriated in this item if the initial appropriation is insufficient to pay the principal and interest on the identified mandate claims (see Attachment 1).

Add the following provision to Item 8885-295-0001:

4. The amount appropriated in Schedule (6) shall be for the payment of local mandate claims associated with expired and repealed mandates. Within 30 days of the enactment of the Budget Act of 2018, the Controller shall notify the Department of Finance whether the amount appropriated in Schedule (6) is sufficient to pay the identified claims, including interest. If the Controller determines the appropriation is insufficient, the Director of the Department of Finance may, after providing 30-days' notice to the chairperson of the Joint Legislative Budget Committee, direct the Controller to augment Schedule (6) by an amount sufficient to pay the identified claims. It is the intent of the Legislature that all local mandate claims associated with expired and repealed mandates be paid no later than November 1, 2018.

# Amendment to Budget Bill Item 9210-102-0001, Local Assistance, Local Government Financing

It is requested that Item 9210-102-0001 be increased by \$9,245,000 to provide additional reimbursement for counties, cities, and special districts for property tax losses resulting from the 2017 wildfires and resultant mudslides.

The Governor's Budget included \$23,736,000 for only the Northern California fire-related property tax losses, because the Southern California property tax losses were unknown at that time. The increase accounts for these Southern California losses.

It is also requested that provisional language be added to authorize the additional payment of property tax losses resulting from the 2017 wildfires and mudslides, if the amount appropriated in this item is insufficient to backfill actual losses. The provisional language will also require the return by local agencies of any remittances that are eventually determined to exceed actual losses (see Attachment 1).

Add the following provision to Item 9210-102-0001:

4. If the amount appropriated in this item is insufficient to backfill actual property tax revenue losses, the county auditor-controller may submit to the Department of Finance a claim detailing the insufficiency no later than December 1, 2019. The Department of Finance may review the insufficiency claim and include the approved claim amounts in a subsequent Governor's Budget. By December 1, 2019, county auditor-controllers shall also determine if a local agency that received reimbursement was reimbursed in an amount that exceeded its actual property tax revenue loss. If the auditor-controller makes such a determination, he or she shall notify the Department of Finance and remit the excess portion to the State Controller.

### Amendment to General Obligation Bond Debt Service

**General Obligation Bonds (Issue 400)**—The payment of General Obligation (GO) Bond debt service is a constitutional appropriation. Therefore, this letter is for informational purposes only.

The statewide GO Bond debt service cost for fiscal year 2017-18 is revised to \$6,835.6 million (\$4,700.6 million General Fund and \$2,135 million other funds), a decrease of \$106.9 million (\$75 million General Fund and \$31.9 million other funds).

The decreases are attributed to the refunding of bonds to achieve lower debt service costs and premium received on new bond issuances. The 2017-18 GO Bond debt service includes \$174.9 million funded directly by the University of California (UC) and \$168.2 million by California State University (CSU), a decrease of \$316,000 for both UC and CSU from what was estimated in the 2018-19 Governor's Budget.

The statewide estimated GO Bond debt service cost for 2018-19 is revised to \$7,250.8 million (\$4,957.5 million General Fund and \$2,293.3 million other funds), an increase of \$144.9 million (\$86.3 million General Fund and \$58.6 million other funds).

This increase is attributed to higher than forecasted interest rates, higher than anticipated principal payments from the spring sales, and higher future sales estimates. The 2018-19 GO Bond debt service includes \$185.1 million funded directly by the UC and \$177.7 million by CSU, (an increase of \$368,000 and \$298,000 respectively) from what was estimated in the Governor's Budget.

## Amendment to Budget Bill Item 9658-011-0001, Support, Budget Stabilization Account

It is requested that Item 9658-011-0001 be amended to reflect revised estimates to the Governor's Budget.

Specific amendments are proposed in the following language:

Provisions:

 Notwithstanding any other provision of law, the amount in this item shall be first applied towards any transfers to the Budget Stabilization Account (BSA) required by Section 20 of Article XVI of the California Constitution for fiscal years 2017-18, 2018-19, and 2019-20, in excess of the sum (\$4,648,000,000) (\$5,978,000,000) projected in the revised estimates to the 2018-19 Governor's Budget (as detailed in the schedule below). For the purposes of this provision, transfers to the BSA required by Section 20 of Article XVI of the California Constitution include the base transfers and subsequent true up transfers for fiscal years 2017-18 through 2019-20, as calculated by the Department of Finance.

2. For the purpose of Provision 1, the calculated required base transfers and subsequent true up transfers include any amount of calculated transfers that would result in a balance in the

BSA exceeding 10 percent of General Fund proceeds of taxes for the fiscal year if the amount were to be transferred to the BSA. This excess amount shall not be transferred to the BSA and instead shall be expended on infrastructure, including deferred maintenance, as required by subdivision (e) of Section 20 of Article XVI of the California Constitution.

- 3. The initial transfer of the remaining amount authorized by this item as calculated by the Department of Finance shall occur no earlier than May 20, 2019. The amount appropriated in this item shall be available for encumbrance until June 30, 2022.
- 4. Section 22 of Article XVI of the California Constitution applies to funds to be transferred, or transferred, to the BSA under this item, except for any amount that would result in a balance in the BSA exceeding 10 percent of General Fund proceeds of taxes for the fiscal year, as calculated by the Department of Finance.
- 5. The amount appropriated in item 9658-011-0001 of the 2016 Budget Act shall be available for encumbrance until June 30, 2019."

# Amendment to Budget Bill Items 9800-001-0001, 9800-001-0494, and 9800-001-0988, Support, Augmentation for Employee Compensation
