Amendment to Various Budget Bill Items, Support and Local Assistance, Employment Development Department

Employment Development Department (EDD) Accounting Resources—It is requested that Item 7100-001-0185 be increased by \$3,475,000 and 8 positions and Item 7100-001-0588 be increased by \$3,475,000 and 7 positions, totaling \$6,950,000 and 15 positions to provide EDD resources to complete accounting transactions in its legacy system to meet federal reporting requirements necessary to provide unemployment benefits without interruption while also transitioning to a more modern accounting platform in the Financial Information System for California. This includes accounting staff and up to \$5 million for vendor services to manage this temporary additional workload and allow for successful transition to the new system.

Additionally, it is requested that provisional language be added to Items 7100-001-0185 and 7100-001-0588 to extend the encumbrance period until June 30, 2020 (see Attachment 1).

**Unemployment Insurance (UI) Loan Interest Rate Increase**—It is requested that Item 7100-002-0001 be increased by \$300,000 to reflect an increase in interest due to the federal government for borrowing that has occurred to provide unemployment benefits without interruption.

Workforce Innovation Opportunity Act (WIOA) Discretionary Fund Adjustments—It is requested that Items 7100-001-0869 and 7100-021-0890 each be increased by \$1,747,000 to reflect funds carried forward from the prior year and an increase in discretionary funds from the federal allotment. This includes a \$3,114,000 increase in WIOA discretionary administration funds, a \$1,770,000 decrease of WIOA program funds, and a \$403,000 increase in Rapid Response funding. This adjustment also includes increased funding for the Regional Workforce Accelerator Program and High Performing Boards, but reduced funding for the Slingshot 2.0 Program, Model Multiple-Employer Industry Sector Programs, and Services for In-School At-Risk Youth program to align authority with anticipated funding.

**Disability Insurance (DI) Benefit Adjustments**—It is requested that Item 7100-101-0588 be increased by \$172,066,000 to reflect a projected increase in benefit payments for the DI program as well as the Paid Family Leave program.

Additionally, the DI benefit authority in fiscal year 2017-18 is decreased by \$66,456,000 due to a decrease in the average weekly benefit amount.

**WIOA Local Assistance Adjustments**—It is requested that Items 7100-101-0869 and 7100-101-0890 each be increased by \$7,326,000 to align budget authority with current federal allotments for local area activities.

It is further requested that Provision 2 of Item 7100-101-0869 be added to allow the EDD to spend federal grant dollars for local youth programs if actual receipts are underestimated (see Attachment 1).

**UI Benefit Adjustments**—It is requested that Items 7100-101-0871 and 7100-111-0890 each be increased by \$6,114,000 to reflect a projected increase in UI benefit payments due to an increase in the average weekly benefit amount, while the unemployment rate is projected to remain steady.

Additionally, the UI benefit authority in 2017-18 is decreased by \$249,594,000 due to a decrease in unemployment levels.

**School Employees Fund Adjustments**—It is requested that Item 7100-101-0908 be increased by \$8,864,000 to reflect a projected increase in benefit payments from the School Employees Fund due to updated funding forecasts.

Additionally, the benefit authority in 2017-18 is increased by \$3,526,000 due to technical adjustments to align budget authority for these operations.

The effect of my requested action is reflected on the attachment.

Add the following provision to Item 7100-001-0185:

4. Add the following provision to Item 7100-001-0588:
