Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, Energy Resources Conservation and Development Commission and Department of General Services

**Energy Resources Programs Account (ERPA) Structural Deficit Relief**—The Energy Resources and Development Commission (Energy Commission) proposes a series of actions, which include increasing revenues and shifting some expenditures to other funds, to address the structural deficit in the ERPA.

ERPA's revenue source is a surcharge on statewide electricity consumption which funds the Energy Commission, Department of General Services, Department of Water Resources, and California Alternative Energy and Advanced Transportation Financing Authority who administer a variety of statewide energy programs, such as appliance and building energy efficiency and renewable self-generation of electricity, both of which are critical in implementing California's aggressive climate change policies. Since the Energy Commission's programs have been successful in decreasing energy consumption and increasing generation of off-grid electricity. revenues generated by the ERPA surcharge have leveled off and are projected to remain flat over time. Meanwhile, increasing program demands on the Energy Commission, including the California Clean Energy Jobs Act (Proposition 39), Building Energy Benchmarking Program (Chapter 590, Statutes of 2015), and Comprehensive Energy Efficiency Program for Existing Buildings (Chapter 470, Statutes of 2009), have required higher ERPA appropriations, with expenditures now exceeding revenues. To keep ERPA solvent and continue funding these important programs, the Energy Commission proposes to convert a portion of ERPA and Renewable Resource Trust Fund (RRTF) expenditures to other appropriate funding sources. RRTF supports California's renewables portfolio standard (RPS), but its revenue source expired in 2012. When the ongoing RPS program depletes RRTF funding, it will place additional demands on ERPA.

Therefore, it is requested that Item 3360-001-0382 be decreased by \$2.1 million and 14 positions, Item 3360-001-0465 be decreased by \$7,345,000 and 43 positions, Item 3360-001-3062 be amended to add 13 positions, and Item 3360-001-3237 be increased by \$8,169,000 and 44 positions. These adjustments are necessary to reflect the conversion of 57 positions from RRTF and ERPA to the Cost of Implementation Account, Air Pollution Control Fund (COIA) and the Energy Facility License and Compliance Fund. Of the approximate \$8.2 million COIA amount, \$7.6 million reflects the conversion of RRTF and ERPA expenditures to COIA, and the additional \$600,000 reflects the conversion of the triennial cycle appropriation to conduct vehicle surveys.

It is also requested that Item 7760-001-0140 be increased by \$1,990,000 and 7.8 positions one-time and Item 7760-001-0465 be decreased by \$1,990,000 and 7.8 positions, to shift the Department of General Service's (DGS) expenditures for energy efficiency, conservation, and clean generation for state agencies to the California Environmental License Plate Fund. DGS will evaluate appropriate mechanisms to fund these expenditures, beginning in fiscal year 2019-20.

The Energy Commission also proposes to increase the ERPA surcharge on energy consumption, from \$0.00029 per kilowatt hour to the statutory cap of \$0.0003 per kilowatt hour. If effective January 2019, the surcharge increase would raise ERPA revenues by \$1,250,000 in 2018-19 and \$2.5 million ongoing.

Agricultural Energy Efficiency Program—It is also requested that Item 3360-101-0001 be added in the amount of \$30 million one-time for the Agricultural Efficiency Program (see Attachment 1). This proposal supplements the amount of grant funding provided in the February 2, 2018 Cap and Trade Expenditure Plan Spring Finance Letter for energy efficiency and greenhouse gas emissions reductions in the food processing sector.

Disadvantage Community Advisory Group (Advisory Group)—It is requested that trailer bill language be added to provide reimbursement for reasonable expenses and a per diem for members of the Advisory Group authorized under the Clean Energy and Pollution Reduction Act of 2015 (Chapter 547, Statutes of 2015). Authorization to reimburse members for their participation in the Advisory Group will enable proper rural and urban, cultural and ethnic, and geographic representation. These members are not paid to serve on the Advisory Group. If reimbursements cannot be provided to members who must travel from all parts of the state, it creates a disincentive to serve on this critical advisory group and risks underrepresentation from certain groups or regions where the financial burden of participation is most acute.

# Amendment to Various Budget Bill Items and Reimbursements, Support, Department of Forestry and Fire Protection

**Climate Change Fire Severity**—It is requested that the following items be amended to provide the Department with additional resources to meet the demands of the extended fire season and increases in the number and severity of wildfire events.

- Increase Item 3540-001-0001 by \$9,607,000 and 52 positions, and reimbursements by \$1,225,000
- Increase Item 3540-001-0102 by \$12,000
- Increase Item 3540-001-0198 by \$10,000
- Increase Item 3540-001-0209 by \$13,000
- Increase Item 3540-001-3212 by \$55,000

This proposal will: (1) add 25 Heavy Equipment Mechanics to perform scheduled maintenance and critical on-site repairs to keep frontline assets operational during wildfire events, (2) provide additional mobile equipment repair and maintenance funding, and (3) support 27 mission critical administrative positions to address incident-driven workload.

The resources requested in this proposal have been funded at varying levels through droughtrelated augmentations provided to the Department over the past several years. As with the fiscal year 2017-18 Climate Adaptation Extended Fire Season Budget Change Proposal, this request recognizes the need to make these resources permanent in light of the continued increase in fire activity across the state.

Office of the State Fire Marshal, Fire and Life Safety Division—It is requested that Item 3540-001-0001 be amended by increasing reimbursements by \$4,029,000 and 15 positions to support the Office of the State Fire Marshal's Fire and Life Safety Division's increased workload related to its plan review, construction inspection, and mandated interval inspection activities. It is also requested that provisional language be added to authorize a General Fund loan of up to \$2.3 million to be repaid over three years (see Attachment 1). These requests are initial outcomes of an ongoing Mission Based Budget review the Department of Finance is performing with the Office of the State Fire Marshal.

Fireworks Program—It is requested that Item 3540-001-0140 be increased by \$3.6 million and 2 positions to provide the Office of the State Fire Marshal's Fire Engineering Division with additional resources to (1) fund one-time disposal costs to address the Division's current stockpile of damaged illegal and dangerous fireworks and (2) reflect changes to its fireworks management and disposal program. It is also requested that provisional language be added to make this funding subject to the enactment of pending legislation that would establish an extended producer responsibility program for fireworks (see Attachment 2).

Reappropriation of Control Section 6.10 Deferred Maintenance Funding—It is requested that Item 3540-492 be amended to reappropriate the unencumbered balance of the deferred maintenance funding appropriated pursuant to Control Section 6.10 of the Budget Act of 2016 with funding available for encumbrance or expenditure until June 30, 2019 (see Attachment 3).

Amendment to Budget Bill Item 3790-496, and Addition of Items 3790-311-0001 and 3790-301-0005, Capital Outlay, Department of Parks and Recreation

**Reversion (Issue 400)**—It is requested that Item 3790-496 be amended to revert the unencumbered balance of funding, estimated to be \$189,000, for the Malibu Creek State Park: Restore Sepulveda Adobe project (see Attachment 1). Project completion is anticipated in fall 2018 and there are savings to be reverted.

California Indian Heritage Center (Issue 401)—It is requested that Item 3790-311-0001 be added in the amount of \$100 million for transfer to the Natural Resources and Parks Preservation Fund. It is also requested that trailer bill language be added to appropriate \$100 million for the design and construction of the California Indian Heritage Center project (see Attachment 2). This project will replace the State Indian Museum constructed in 1940 on the grounds of Sutter's Fort State Historic Park, and will bring to fruition a project whose conceptual planning was developed by the California Indian Cultural Center and Museum Task Force pursuant to Chapter 290, Statutes of 2002 (SB 2063).

Fort Ross State Historic Park: Cultural Trail (Issue 402)—It is requested that Item 3790-301-0005 be added in the amount of \$852,000 for the preliminary plans (\$537,000) and working drawings (\$315,000) phases of the Fort Ross State Historic Park Cultural Trail project (see Attachment 3). The project will create an interpretive multimedia experience by exploring stories from indigenous Kashia Band of Pomo Indians; Alaska Natives and others in the international community once associated with the Russian American Company's Ross Settlement; and the Call Ranch family's history.

Amendment to and Addition of Various Budget Bill Items, Support, Capital Outlay, and Trailer Bill Language, Department of Water Resources, Department of Fish and Wildlife, and State Water Resources Control Board

Flood Control Infrastructure—It is requested that Item 3860-001-0001 be increased by \$45 million to: (1) provide the support costs associated with urban flood control projects, and (2) support ongoing levee maintenance. Funds for operations and maintenance will provide incentives for cost-sharing with local maintaining agencies by encouraging a regional flood governance model and updating assurance agreements to clarify levee maintenance responsibilities. It is also requested that provisional language be added to specify funding available for each of the above activities and associated encumbrance periods (see Attachment 1).

It is requested that Item 3860-301-0001 be increased by \$150 million to support the state cost-share of U.S. Army Corps of Engineers' urban flood control projects that will contribute to a 200-year level of flood protection in urban areas of the Central Valley and will strengthen the state's ability to leverage approximately \$690 million in federal funding. It is also requested that provisional language be added to specify which urban flood control projects may be funded and to provide an extended encumbrance until June 30, 2023 (see Attachment 2).

It is further requested that trailer bill language be adopted to make various changes to the Delta Levee Maintenance Program.

**Save our Water Campaign**—It is requested that Item 3860-001-0140 be increased by \$300,000 to support outreach and advertising associated with the Save Our Water campaign to promote water conservation as a way of life. This proposal will allow the Department of Water Resources to continue advertising on major platforms including digital, radio, billboards, and other emerging media channels.

**Open and Transparent Water Data Act (AB 1755)**—It is requested that Item 3600-001-0140 be increased by \$150,000, Item 3860-001-0140 be increased by \$450,000, and Item 3940-001-0140 be increased by \$200,000 to continue implementation of Chapter 506, Statutes of 2016 (AB 1755). Additionally, it is requested that provisional language be added to these items to specify the purpose of this funding (see Attachment 3). This request provides two-year limited-term funding for the Department of Fish and Wildlife and the State Water Resources

Control Board to convert existing data for inclusion in the water data platform required by AB 1755, as well as consultation with the Department of Water Resources. Ongoing funding for the Department of Water Resources will support the necessary IT software subscriptions for the water data platform.

**Dam Safety Trailer Bill Language**—It is requested that trailer bill language be adopted to clarify the process for dam owners where there is an existing or partial Emergency Action Plan (EAP) or inundation map as of March 1, 2017 (see Attachment 4). The amendments also require dam owners with partial EAPs or inundation maps to develop a timeline by which they will develop the comprehensive EAP and inundation maps.

Reappropriation and Technical Adjustment (Propositions 1 and 13)—It is requested that Provision 2 of Item 3860-001-6026 as added in the April 1 Finance Letter be amended to make funds available for support and local assistance (see Attachment 5). It is also requested that Item 3860-493 be added to reappropriate \$10 million or the balance of Item 3860-111-6083, Budget Act of 2015 (Chs. 10 and 11, Stats. 2015), with funding available for encumbrance or expenditure until June 30, 2020 (see Attachment 6).

1. Notwithstanding Section 21190 of the Public Resources Code, \$200,000 of the amount appropriated in this item may be used to support implementation of Chapter 506, Statutes of 2016 (Open and Transparent Water Data Act).

Section 6161 of the Water Code is amended to read:

- (a)(1) An owner of a state jurisdictional dam, except an owner of a dam classified by the department pursuant to Section 6160 as a low hazard dam, shall submit electronically to the department an inundation map that shows the area that would be subject to flooding under various failure scenarios unique to the dam and the critical appurtenant structures of the dam.
- (2) Before approval of an inundation map, the department shall review the map and may require the owner to make changes that the department deems necessary.
- (3) Upon approval of the inundation map or maps by the department, the owner of the dam shall develop and submit <u>electronically</u> to the department and the Office of Emergency Services <del>based upon the approved inundation map or maps</del> an emergency action plan that is based upon the approved inundation map or maps.
- (4) If an owner of a dam has an existing emergency action plan as of March 1, 2017, the department shall review an inundation map(s) contained in the plan. If the department determines that the inundation map(s) are sufficient, in one of the contexts described below, the owner of the dam shall submit the emergency action plan associated with those inundation map(s) to the department shall request the Office of Emergency Services to review the emergency action plan associated with that inundation map as provided below:
- (A) If the emergency action plan that existed as of March 1, 2017, contains inundation maps for the dam and all critical appurtenant structures, where critical appurtenant structures exist, and the department determines that the inundation maps for the dam and all critical appurtenant structures, where critical appurtenant structures exist, are sufficient, then the owner of the dam shall submit the complete emergency action plan reflecting all critical appurtenant structures to the Office of Emergency Services for review within 30 days of department approval.
- (B) If the emergency action plan that existed as of March 1, 2017, contains an inundation map for the dam but not for all of the critical appurtenant structures, then the department shall review the map included in the existing emergency action plan for sufficiency. Upon approval by the department, the owner of the dam shall submit the existing emergency action plan associated with the approved map to the Office of Emergency Services. The owner of the dam shall continue to prepare inundation maps, with due diligence, for the remaining critical appurtenant structures, submit to the department for review and approval. The Office of Emergency Services may defer review and approval of the new or updated emergency action plan until the Office of Emergency Services has received inundation maps approved by the department for the dam and all critical appurtenant structures. If the Office of Emergency Services approves the interim emergency action plan under this subsection, then an owner of a dam may use that emergency action plan that existed as of March 1, 2017, on an interim basis, pending approval of a new or updated emergency action plan that includes maps for the dam and all critical appurtenant structures.
- (C) For purposes of this section, due diligence means that the owner of a dam is progressing toward completion of inundation maps for all critical appurtenant structures according to a reasonable schedule proposed by the owner of the dam and approved by the department.

When evaluating the time schedule, the department may consider, among other relevant factors, the hazard classification of the dam, the number of critical appurtenant structure inundation maps that are outstanding, and the complexity of the failure scenarios. An owner of the dam shall submit a time schedule no later than 60 days after the effective date of this provision. Failure to submit a time schedule or comply with an approved time schedule may result in the imposition of penalties, restrictions, or liens pursuant to Water Code Division 3, Part 1, Chapter 8. After the department approves the maps for the critical appurtenant structures, the dam owner shall submit the new or updated emergency action plan, including the approved maps, to the Office of Emergency Services within 60 days.

- (b)(1) The Office of Emergency Services shall review and approve an emergency action plan no later than 60 days after receipt of the plan from the dam owner pursuant to Section 8589.5 of the Government Code. To the extent possible, the Office of Emergency Services shall give priority to a dam with the highest hazard classification as determined by the department pursuant to Section 6160.
- (2) If the Office of Emergency Services determines a proposed emergency action plan does not meet the requirements of Section 8589.5 of the Government Code, the Office of Emergency Services shall inform the owner of the dam and require the owner of the dam to amend and resubmit the emergency action plan for approval. The Office of Emergency Services shall review and, if the emergency action plan meets the requirements of Section 8589.5 of the Government Code, approve a resubmitted emergency action plan within 30 days of receipt from the owner of the dam.
- (3) Upon approval by the Office of Emergency Services of an emergency action plan, the Office of Emergency Services shall notify the department and the owner of the dam of the approval. The owner of the dam shall ensure that the approved emergency action plan is disseminated to appropriate public safety and emergency management agencies in potentially affected jurisdictions, to the extent these agencies wish want to receive approved emergency action plans.
- (c)(1) The department shall make an approved inundation map, as well as any schedule submitted pursuant to subdivision (a)(4)(C), publicly available.
- (2) Nothing in Chapter 3.5 (commencing with Section 6250) of Division 7 of Title 1 of the Government Code shall be construed to require disclosure of an emergency action plan.
- (d)(1) Pursuant to the classification by the department under Section 6160, an owner of a dam shall complete and submit an emergency action plan as follows:
  - (A) On or before January 1, 2018, if the hazard classification of the dam is extremely high.
  - (B) On or before January 1, 2019, if the hazard classification of the dam is high.
  - (C) On or before January 1, 2021, if the hazard classification of the dam is significant.
- (2) An owner of a dam who has an existing emergency action plan as of March 1, 2017, that the department determines has a sufficient inundation map and that the Office of Emergency Services determines has a sufficient emergency action plan pursuant to paragraph (4) of subdivision (a) is not subject to the timelines set forth in paragraph (1).

- (e) An owner of a dam shall update an emergency action plan, including an inundation map, no less frequently than every 10 years, and sooner under conditions that include, but are not limited to, the following:
- (1) A significant modification to the dam or a critical appurtenant structure, as determined by the department.
- (2) A significant change to downstream development that involves people and property.

Amend Provision 2 of Item 3860-001-6026 as added in the April 1 Finance Letter, as follows:

"2. The funds appropriated in this item shall be available for encumbrance or expenditure until June 30, 2021, for support or local assistance."

# Amendment to Budget Bill Item 3860-301-0001, Capital Outlay, Department of Water Resources

Joint Operations Center Relocation (Issue 301)—It is requested that Item 3860-301-0001 be increased by \$964,000 to prepare a request for proposal to acquire a Joint Operations Center (JOC) (see Attachment 1). In addition, \$926,000 State Water Project funds will be used for this purpose. Provisional language is also requested to allow the Department of General Services, with consent from the Department of Water Resources, to enter into a build-to-suit lease for this project.

The proposed project, to be jointly occupied by the state and federal partners, is estimated to be approximately 282,000 square feet (247,000 sf state and 35,000 sf federal). The estimated total cost to acquire, design, and construct the JOC is \$265.2 million (\$116.3 million General Fund, \$111.8 million State Water Project, and \$37.1 million federal reimbursement). The state's portion will be comprised of 51 percent General Fund and 49 percent continuously appropriated State Water Project funds. A new JOC is necessary, as the current facilities no longer meet programmatic space needs, do not conform to federal requirements of being located outside of the 100-year floodplain, and lack enough perimeter setback space to meet federal security requirements.

Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, Various Departments, Forest Carbon Plan

The Forest Carbon Plan initiative provides \$96 million for programs and projects to improve the health and resiliency of California's forests to protect against the worsening threats of fire and disease driven by climate change.

## **Government Operations Agency**

California Mass Timber Building Competition—It is requested that Item 0511-001-3212 be added in the amount of \$500,000 to support implementation of the California Mass Timber Building Competition (see Attachment 1). This funding will be used to develop the competition and provide grants to local jurisdictions to showcase the architectural design of mass timber buildings.

## **California Natural Resources Agency**

Northern, Coastal, and Southern California Regional Forest Health Projects—It is requested that Item 0540-101-3228 be added in the amount of \$20 million for block grants to support regional implementation of landscape-level forest health projects (see Attachment 2). This will facilitate the expansion of the Sierra Nevada Conservancy's Watershed Improvement Program model to the Northern, Coastal, and Southern California regions.

## **Department of Conservation**

Watershed Coordinator Grants for Priority Watersheds—It is requested that Item 3480-101-0140 be added in the amount of \$1,890,000 to provide local assistance grants to fund watershed coordinator positions to facilitate the development and implementation of regional watershed improvement plans (see Attachment 3).

**Department of Forestry and Fire Protection** 

**Joint Institute for Wood Products Innovation**—It is requested that Item 3540-001-3212 be increased by \$750,000 and 1 position for the Board of Forestry and Fire Protection to develop and implement a Joint Institute for Wood Products Innovation to encourage markets for wood products (see Attachment 4).

Prescribed Fire and Fuels Reduction—It is requested that Item 3540-003-3228 be added in the amount of \$26,838,000 and 79 positions for the Department of Forestry and Fire Protection (CAL FIRE) to complete more prescribed fire and fuel reduction projects through various actions, including operation of six year-round prescribed fire crews and development of a research and monitoring program (see Attachment 5). ## **Department of Parks and Recreation**

**Legacy Forests at State Parks**—It is requested that Item 3790-002-6088 be added in the amount of \$15 million to fund forest restoration activities in state parks with a focus on protecting legacy forests with significant natural resource values (see Attachment 6). This funding will support restoration efforts in state parks throughout the state, including coastal redwoods, central Sierra sequoias, coastal pines, and oak woodlands.

## Sierra Nevada Conservancy

**Sierra Regional Forest Health Projects**—It is requested that Item 3855-001-6088 be increased by \$4 million and 2 positions, Item 3855-101-6088 be increased by \$15,325,000, and Item 3855-102-6088 be added in the amount of \$10,675,000 to support implementation of the Sierra Nevada Conservancy's Watershed Improvement Program and fund shovel-ready large landscape projects developed through cross-agency collaboration (see Attachment 7).
