Amendment to Various Budget Bill Items and Reimbursements, Support, Department of Tax and Fee Administration

Redirected Vacancies for Accounting Workload, Per Provision 1 (Issue 300)—It is requested that Item 7600-001-0001 be decreased by \$11,000 and reimbursements be decreased by \$16,000, and that various Budget Bill items be amended to support the redirection and reclassification of 5 vacant revenue-generating positions to accounting activities. The California Department of Tax and Fee Administration (CDTFA) has critical accounting needs and requires the additional support. The CDTFA's budget includes provisional language requiring legislative approval of any redirections of revenue-generating positions to activities that do not directly generate revenue.

It is further requested that the California Cannabis Tax Fund be increased by \$6,000, the California Healthcare, Research and Prevention Tobacco Tax Act of 2016 Fund be increased by \$2,000, and the Department of Tax and Fee Administration Subaccount, Tobacco Law Enforcement Account, California Healthcare, Research and Prevention Tobacco Tax Act of 2016 Fund be increased by \$7,000.

Relinquished Resources for Prepaid Mobile Telephony Services Surcharge Program (Issue 301)—It is requested that Item 7600-001-3251 be decreased by \$1,469,000 and 6.5 positions and Item 7600-001-3270 be increased by \$503,000 and be decreased by 0.6 position, so that the CDTFA can relinquish resources and efficiently phase out the Prepaid Mobile Telephone Services Surcharge Program. In November 2018, a federal court ruled that a portion of the Program was invalid, leading the CDTFA to stop collecting revenues for the Prepaid Mobile Telephony Services Surcharge Fund. The remaining portion of the program, which collects revenues and expends administrative costs through the Local Charges for Prepaid Mobile Telephony Services Fund, is scheduled to sunset at the end of 2019.

Amendment to Budget Bill Items 7760-001-0003 and 7760-001-0666, Support, Department of General Services

Facilities Management Division (FMD) Increased Operational Costs—It is requested that Item 7760-001-0666 be increased by \$30,149,000 to support operational costs that have increased over time. The Department of General Services (DGS) assesses a statewide surcharge to state entities to recover costs associated with central services provided by the DGS. The FMD can no longer absorb significant cost increases related to statewide surcharge services. This request will also provide a permanent augmentation to cover costs for partial services for clients in non-DGS owned buildings, workers' compensation and insurance costs, as well as general economic inflation and cost-of-living adjustments for maintenance, security, and contract costs.

Statewide Parking Program—It is requested that Item 7760-001-0003 be increased by \$4,545,000 and Item 7760-001-0666 be decreased by \$2,345,000 to support the transition of nine parking facilities from the FMD to the Office of Fleet and Asset Management (OFAM) and to upgrade parking equipment and technology in select facilities. The DGS is consolidating parking management under the OFAM to ensure the application of consistent parking policies. This request will shift expenditure authority from the FMD to the OFAM in support of that transition. In addition, the DGS is upgrading certain facilities to a Parking Access and Revenue Control System. Updating the parking facilities with a new system will reduce manual processes, introduce a self-service function for customers, and provide the necessary technology to increase efficiency and occupancy tracking. This request will provide one-time funding to cover the costs necessary for the upgraded system.

Office of Sustainability Energy Resources Program Account (ERPA) Funding Replacement—It is requested that Item 7760-001-0666 be increased by \$2,052,000 and 7.9 positions to support expenditures for energy efficiency, conservation, and clean energy generation for state agencies. The ERPA's revenue source is a surcharge on statewide electricity consumption, which funds certain state entities who administer a variety of statewide energy programs. Revenues generated by the ERPA surcharge have leveled off. Consequently, the DGS' Office of Sustainability received funding from the California Environmental License Plate Fund on a one-time basis. This request will add the program to the statewide surcharge and provide a permanent funding source beginning in fiscal year 2019-20 to continue these activities.
