Amendment to Budget Bill Items 0890-001-0001, 0890-001-0228, and 0890-001-3244, and Addition of Item 0890-001-3254, Support, Secretary of State

Financial Information System for California (FI\$Cal) Workload—It is requested that Item 0890-001-0001 be increased by \$395,000 and 7 positions and Item 0890-001-0228 be increased by \$1,063,000 to support additional workload as a result of the Secretary of State's (SOS) transition to FI\$Cal. This request will provide the SOS with ongoing resources necessary to meet increased workload in the budget, procurement, and accounting sections.

California Automated Lobbying and Campaign Contribution and Expenditure Search System (Cal-ACCESS) Replacement Project—It is requested that Item 0890-001-0001 be increased by \$6,992,000 and Item 0890-001-3244 be increased by \$700,000 to continue the design and development of a Cal-ACCESS replacement system. The current Cal-ACCESS system is approaching the end of its useful lifecycle. This request will provide the SOS with one-time funding necessary to continue the support of staff resources and to procure contracted services.

California Business Connect (CBC)—It is requested that Item 0890-001-0228 be increased by \$10,629,000 and Item 0890-001-3254 be added in the amount of \$2 million to continue implementation of the CBC project. The CBC is a comprehensive technology solution that will increase online services for business filings and requests for information. Once implemented, the CBC will provide one system with similar applications for various filings and the necessary interfaces within the SOS and with customers, including other governmental agencies. This request will provide one-time resources necessary for contracting and consulting services for system integration vendors and project management services, and other operating expenses related to the project.

Cybersecurity Remediation and Enhancements—It is requested that Item 0890-001-0001 be increased by \$742,000 and 4 positions and Item 0890-001-0228 be increased by \$2,005,000 for the SOS' cybersecurity program to ensure continuous identification and mitigation of cybersecurity risks. Proper cybersecurity defenses are necessary to effectively detect and protect against these threats. This request will provide funding for staff, infrastructure replacement, contracted services, and ongoing maintenance for monitoring and notification tools.

Voter Information Internet Website—It is requested that Item 0890-001-0001 be increased by \$250,000 to meet the requirements of Chapter 920, Statutes of 2018 (AB 2707). AB 2707 requires the SOS to provide voters access to information regarding their elected federal, state, local, and special district representatives. This request will provide funding to procure a service that has the ability to consolidate required data and publish the information on the SOS website.
