# Amendment to Various Budget Bill Items, Support and Capital Outlay, Various Departments within the Natural Resources Agency and Environmental Protection Agency

**Proposition 99 Technical Adjustments**—It is requested that various Budget Bill items be amended to reflect this technical baseline budget adjustment for various departments within the Natural Resources Agency and Environmental Protection Agency to reflect additional tobacco tax revenue for the Public Resources Account. Revenue and Tax Code section 30124(b)(5) specifies that 5 percent of Cigarette and Tobacco Products Surtax Fund revenue shall be deposited into the Public Resources Account for programs that protect, restore, enhance, or maintain fish, waterfowl, and wildlife habitat, and enhance state and local parks and recreational resources.

It is requested that the following items be amended to reflect this change:

- Increase Item 0555-001-0235 by \$7,000
- Increase Item 3600-001-0235 by \$167,000
- Increase Item 3790-001-0235 by \$468,000
- Increase Item 3940-001-0235 by \$27,000

It is also requested that Item 3640-311-0001 be decreased by \$256,000. This adjustment is associated with corresponding increased May Revision revenues from the Unallocated Account Cigarette and Tobacco Products Surtax fund that offset General Fund expenditures pursuant to Fish and Game Code section 2796.

# Amendment to Budget Bill Item 3480-001-3046 and Addition of Items 3480-490 and 3480-495, Support, Department of Conservation

**Well Statewide Tracking and Reporting System**—It is requested that Item 3480-001-3046 be increased by \$3,170,000, and that Item 3480-490 be added to expand the scope and functionality of the Well Statewide Tracking and Reporting (WellSTAR) System (see Attachment 1). Legislation enacted after the original scope of the project was developed, along with subsequent regulatory changes, have expanded the functionality requirements placed on the Department of Conservation and the WellSTAR project. Although the existing WellSTAR Information Technology project remains within scope, on time, and within budget as initially planned, the additional functionality requested will incorporate enhancements necessary to meet the requirements of recent regulatory and legislative changes.

**Technical Bond Adjustments**—It is requested that Item 3480-495 be added to revert unexpended bond funds from Items 3480-101-6029 and 3480-101-6051, Budget Act of 2016, to prevent over-allocation of bond funds (see Attachment 2).

# Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support, and Trailer Bill Language, Department of Forestry and Fire Protection

**Community Wildfire Prevention and Mitigation Report: California Vegetation Treatment Program Environmental Impact Report**—It is requested that Item 3540-001-0001 be increased by \$730,000 to support the Board of Forestry and Fire Protection in certifying the Programmatic Environmental Impact Report (EIR) for the California Vegetation Treatment Program consistent with the recommendations in the Department of Forestry and Fire Protection's (CAL FIRE) Community Wildfire Prevention and Mitigation Report. The EIR will enable CAL FIRE and other partner agencies to increase the pace and scale of fire prevention activities and help achieve statewide forest management targets as recommended in the Forest Carbon Plan.

**Office of the State Fire Marshal, Fire and Life Safety Division**—It is requested that the following items be increased to address key resource gaps within the Office of the State Fire Marshal's Fire and Life Safety Division and enhance the Division's ability to fulfill its mission as identified through the ongoing Mission Based Review in collaboration with the Department of Finance:

- Increase Item 3540-001-0001 by \$531,000 and 0.3 position and reimbursements by \$1,499,000 and 6.5 positions
- Increase Item 3540-001-0102 by \$31,000 and 0.3 position
- Increase Item 3540-001-0198 by \$31,000 and 0.3 position
- Increase Item 3540-001-0209 by \$71,000 and 0.6 position

It is also requested that provisional language be added to Item 3540-001-0001 as follows:

- Provide up to \$500,000 General Fund for two fiscal years to the Division for contracts for specified purposes upon approval of the Department of Finance (see Attachment 1).
- Extend the repayment schedule from three years to five years for the \$2.3 million General Fund loan authorized by Item 3540-001-0001, Budget Act of 2018 to address the Division's cash flow needs.
- Make \$500,000 of the \$2.3 million General Fund loan authorized in fiscal year 2018-19 available to the Division in 2019-20.

It is further requested that trailer bill language be adopted to make necessary clarifications and changes to improve and streamline fire and life safety practices statewide. Although the proposed trailer bill language is not attached to this letter, it will be provided in the near future.

**Enhanced Fire Protection May Revision Update: C-130 Federal Air Tankers**—It is requested that Item 3540-001-0001 be increased by \$4,603,000 to support a contract for a large air tanker to respond to wildfires during the peak of the fire year and serve as a training platform for the pilots that will operate the federal C-130 air tankers that will be transferred to CAL FIRE from the U.S. Air Force starting in 2020-21. This proposal is additive to the \$13.1 million proposed in the Governor's Budget to begin implementation of the C-130 program. The funding requested will partially offset Emergency Fund expenditures and enable the state to avoid future costs as the contract will be obtained at a lower rate than if CAL FIRE were to seek the contract during the peak season.

Office of the State Fire Marshal, Licensing and Certification Fund Program Fee and Expenditure Increase—It is requested that Item 3540-001-0102 be increased by \$1,098,000 and 4 positions to build capacity in the Licensing and Certification Program within the Fire Marshal's Fire Engineering Division to address increased workload, create operational efficiencies, and undertake enforcement activities in the Building Materials Listing and Flame Retardant Fabrics and Chemicals Programs. The additional funding and positions requested will be supported through increased fee revenues.

**Innovation Procurement Sprint**—It is requested that Item 3540-005-0001 be added in the amount of \$15 million to enable CAL FIRE to procure innovative solutions to combat the state's wildfire crisis consistent with Executive Order N-04-19 (see Attachment 2). It is also requested that provisional language be added to allow for augmentations of this amount as necessary under specified conditions.

**Professional Forester Registration Program**—It is requested that Item 3540-011-0140 be added in the amount of \$100,000 to reflect a one-time transfer from the Environmental License Plate Fund to the Professional Forester Registration Fund to address a projected structural deficit and maintain current service levels in the Professional Forester Registration Program operated by the Board (see Attachment 3). This will provide additional time to identify a long-term solution to this Fund's projected structural imbalance.

- 11. Notwithstanding any other provision of law, of the \$2.3 million loan authorized by Provision 9 of Item 3540-001-0001, Budget Act of 2018, up to \$500,000 shall be available, upon order of the Department of Finance, for Schedule (1) subject to the conditions specified in subdivisions (a) and (c) of that item. Notwithstanding any other provision of law, upon request from the Department of Forestry and Fire Protection, the Department of Finance may augment this item based on the final contact amount(s) and anticipated need not sooner than 30 days after written notification of the necessity of the increase to the chairperson of the committee in each house of the Legislature that considers appropriations and the Chairperson of the Joint Legislative Budget Committee, or such lesser time as the chairpersons of the committees, or their designees, may in each instance jointly determine.
- 2. Of the amount appropriated in this item, \$10,000,000 shall be available, upon approval from the Department of Finance, for the scope and estimated cost of the selected solution vendor(s) authorized by Executive Order N-04-19, including staffing costs to implement and support the projects. Within 10 days after approval, the Department of Finance shall notify the chairperson of the committee in each house of the Legislature that considers appropriations and the Chairperson of the Joint Legislative Budget Committee of the approved projects, including the scope and estimated cost of each project.

**Erskine Land Restoration**—It is requested that Item 3600-001-0001 be increased by \$325,000 to fund the restoration of federal land that was leased by the Department of Fish and Wildlife in 1987. Restoration of this land will enable the Department to terminate the lease with the Federal Bureau of Land Management and reduce future liability associated with the property.

**Salton Sea Restoration Fund**—It is requested that Item 3600-001-8018 be increased by \$324,000 to align expenditure authority with increased revenues to the Salton Sea Restoration Fund from the Imperial Irrigation District, consistent with the Quantification Settlement Agreement. This funding will support existing and future Salton Sea restoration activities.

### Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support and Local Assistance, Department of Parks and Recreation

**Public Safety Emergency Response (Issue 403)**—It is requested that Item 3790-001-0001 be increased by \$3,873,000 to provide upgraded radio communications infrastructure. These resources will better prepare state park peace officers to respond to disasters.

### Harbors and Watercraft Revolving Fund and State Parks and Recreation Fund

**Stabilization (Issue 401)**—It is requested that Item 3790-001-0001 be increased by \$35,747,000, Item 3790-001-0392 be decreased by \$35,747,000, and that Item 3790-497 be added to revert \$16,410,000 in unexpended funds from the Harbors and Watercraft Revolving Fund (see Attachment 1). Additionally, it is requested that Item 3790-012-0061 be amended to clarify the methodology to be used to implement the transfer of funds from the Motor Vehicle Fuel Account, Transportation Tax Fund to the State Parks and Recreation Fund (see Attachment 2). This funding will maintain general state park service levels while addressing a fuel tax revenue transfer issue that resulted in a structural imbalance in the State Parks and Recreation Fund and the Harbors and Watercraft Revolving Fund. Additionally, this proposal will allow time for the Department of Parks and Recreation to develop a long term solution to the structural imbalance in the Harbors and Watercraft Revolving Fund.

**Credit Card Processing Contract (Issue 402)**—It is requested that Item 3790-001-0392 be increased by \$4 million to issue payments to vendors for merchant processing services. These vendors are currently paid through deductions from the revenue collected on credit card transactions. This proposal would instead require the Department to issue payments to vendors from an appropriation, resulting in the Department receiving all of the revenue collected from credit card transactions. With the corresponding revenue increase, this change in methodology would result in a net zero impact to the fund.

**Wildfire Repair and Reimbursement (Issue 406)**—It is requested that Item 3790-003-0001 be added in the amount of \$7.9 million (see Attachment 3) and that Item 3790-001-0392 be amended by increasing reimbursements by \$2.8 million to repair facilities damaged by wildfire. This proposal includes only the initial funding for repairs as many of the facilities destroyed were originally constructed more than 50 years ago and the Department is evaluating potential

changes to meet modern demands and code requirements before the full replacement of facilities is proposed.

**Public Beach Restoration Projects (Issue 404)**—It is requested that Item 3790-101-0516 be amended by shifting \$750,000 from the Boating Facilities program to the Beach Erosion Control program. Additionally, it is requested that Item 3790-101-3001 be added in the amount of \$231,000 and reimbursements be added in the amount of \$500,000 (see Attachment 4). Funding included in this request will support projects to combat erosion at public beaches.

**Reappropriation of Deferred Maintenance and Public Beach Restoration Funding** (Issue 411)—It is requested that Item 3790-490 as added by the April Finance Letter be amended to reappropriate the unencumbered balance of the appropriation provided in Item 3790-001-0001, Budget Act of 2016 for deferred maintenance projects and up to \$890,000 of the unencumbered balance of the appropriation provided in Item 3790-101-3001, Budget Act of 2017 (see Attachment 5).

# Amendment to and Addition of Various Budget Bill Items, Support and Capital Outlay, Department of Water Resources

**Open and Transparent Water Data Act (AB 1755)**—It is requested that Item 3860-001-0140 be increased by \$1,058,000 to continue implementation of Chapter 506, Statutes of 2016 (AB 1755). AB 1755 requires the Department of Water Resources to develop and manage a statewide water data platform. Additional resources are needed to integrate existing water data into the platform over the next four years.

**Dam Safety Risk Management**—It is requested that Item 3860-001-3057 be increased by \$1,625,000 and 6 positions to develop, implement, and fully integrate risk assessments into the Department's dam safety protocols. This funding will allow the Department to implement recommendations from the dam safety technical advisory panel established pursuant to Chapter 3, Statutes of 2018 (AB 1270). It is further requested that Item 3860-401 be added to forgive the next three years of General Fund Ioan repayments originally provided for dam safety workload associated with Chapter 26, Statutes of 2017 (SB 92) (see Attachment 1). This General Fund Ioan forgiveness will allow the Department to delay dam safety fee increases associated with integrating the advisory panel's recommendations into dam safety protocols.

**Urban Flood Risk Reduction (Project Adjustment)**—It is requested that Item 3860-301-6088 be amended by shifting \$6,140,000 between phases within Schedule (1), with conforming amendments to various urban flood control projects specified in Provision 2, to support construction of the Oroville Wildlife Area Weir Enhancement project (see Attachment 2). The Department is prepared to enter into a construction contract on the Oroville Wildlife Area Weir Enhancement project and therefore needs additional funding to support the contract.

**Salton Sea Reappropriation**—It is requested that Item 3860-490 as proposed in the April 1 Finance Letter be amended to reappropriate the unencumbered balance of Proposition 1 funds for Salton Sea restoration activities (see Attachment 3).
