Addition of Item 7502-002-0001, Support, Department of Technology

Technology Modernization Funding—It is requested that Item 7502-002-0001 be added in the amount of \$50 million to fund technology modernization solutions. The one-time appropriation will fund technology solutions identified by the Department of Technology, and approved by the Department of Finance, through the process of assessing state departments' existing information technology systems and evaluating small but strategic technology proposals submitted by state departments for consideration.

It is further requested that the following provisions be added to Item 7502-002-0001 to conform to this action:

- 1. The amount appropriated in Schedule (1) is for stabilizing and improving various state information technology systems and infrastructures. Prior to the expenditure of funds, the Department of Technology shall submit a prioritized list of information technology system and infrastructure stabilization or improvement projects to the Department of Finance for review and approval.
- 2. Beginning January 1, 2022, and every six months thereafter, the Department of Technology shall provide, to the extent that information is available, the Chairperson of the Joint Legislative Budget Committee, or their designee, and the chairpersons of the committees in each house of the Legislature that consider appropriations, or their designees, a report including (a) all expenditures from Schedule (1), (b) the status of information technology solutions funded by expenditures from Schedule (1), (c) the status and results of information technology, and (d) the prioritized information technology project list approved by the Department of Finance. The prioritized list of information technology projects must include project descriptions and cost estimates in order to satisfy the requirements of this provision.

3. The amount appropriated in this item shall be available for encumbrance or expenditure until June 30, 2024.

Used Motor Vehicle Sales Gap—It is requested that Item 7600-001-0001 be increased by \$5,889,000 to reimburse the Department of Motor Vehicles for costs incurred to collect sales tax from used car dealers associated with the passage of Chapter 8, Statutes of 2020 (AB 85).

It is also requested that provisional language be added to Item 7600-001-0001 as follows:

5. Of the funds appropriated in this item, \$2,139,000 is authorized for expenditure for project funding for the used motor vehicle sales tax gap information technology project, contingent upon approval of the appropriate Project Lifecycle documents by Finance and the Department of Technology, and after the provision of 30 days notification to the Joint Legislative Budget Committee.

Amendment to Budget Bill Item 7730-001-0001 and Addition of Item 7730-490, Support, Franchise Tax Board

Earned Income Tax Credit-The American Rescue Plan Act and In-Home Supportive Services—It is requested that Item 7730-001-0001 be increased by \$2,833,000 and 45 positions to provide assistance to California Earned Income Tax Credit (CalEITC) eligible persons who filed returns for the 2020 tax year noting the receipt of unemployment insurance (UI) benefits, and who are now eligible for increased CalEITC payments due to a recent Internal Revenue Service (IRS) ruling that the first \$10,200 in UI can be excluded from federal adjusted gross income, which is the base on which CalEITC benefits are calculated. This funding will also assist persons who receive income through In-Home Supportive Services (IHSS), and who are impacted by recent IRS and Office of Tax Appeals decisions that IHSS income can be included as earned income for purposes of determining CalEITC eligibility.

Reappropriation of Golden State Stimulus Outreach Funding – It is requested that Item 7730-490 be added to reappropriate \$2 million or whatever greater or lesser amount of the unexpended outreach funds appropriated to the Franchise Tax Board by Chapter 5, Statutes of 2021 (AB 81), for the continued provision of outreach for the Golden State Stimulus (See Attachment 1).

Golden State Stimulus Fund 2.0—It is requested that Item 7730-001-0001 be increased by \$3,405,000 and 46.6 positions for the Franchise Tax Board to administer the Golden State Stimulus 2.0 which expands needed economic relief to broad groups of low and middle income households in California.

Amendment to Budget Bill Items 7760-001-0001 and 7760-001-9740, and Addition of Item 7760-002-0001, Support, Department of General Services

Contracted Fiscal Services Workload Increase—It is requested that Item 7760-001-0001 be increased by \$171,000 ongoing and 1 position, and Item 7760-001-9740 be increased by \$129,000 ongoing and 1 position, to support the addition of the Office of Energy Infrastructure Safety as a client of the Department of General Services' Contracted Fiscal Services Unit.

One-Time Deferred Maintenance Workload—It is requested that Item 7760-001-0001 be increased by \$30 million one-time to fund state building elevator and fire alarm system repair and replacement projects. This request is in addition to the \$20 million General Fund proposal for one-time deferred maintenance workload included in the Governor's Budget.

It is further requested that Provision 3 of Item 7760-001-0001 be amended as follows:

"3. Of the amount appropriated in Schedule (1), \$20,000,000 \$50,000,000 is for state building elevator and fire alarm system repair and replacement projects. This funding is available for these projects only as each discrete project design is completed by the Department of General Services and as each discrete project design cost is reviewed by the Department of Finance. Should these project costs total less than \$20,000,000 \$50,000,000, the difference between total project costs and the amount made available pursuant to this provision shall revert to the General Fund."

Statewide Property Inventory Modernization Project Planning—It is requested that Item 7760-001-0001 be increased by \$214,000 one-time to fund the planning efforts for the Statewide Property Inventory modernization project. It is further requested that the following provision be added to Item 7760-001-0001 as

It is further requested that the following provision be added to Item 7760-001-0001 as follows:

4. Upon order of the Department of Finance, the amount available for expenditure in Schedule (2) may be increased by up to \$2,532,000 to fund the Statewide Property Inventory Modernization Project in the 2021–22 fiscal year. The augmented funds will be available contingent upon approval of the Project Approval Lifecycle documents by the Department of Technology.

California Commission on Disability Access—It is requested that Item 7760-002-0001 be added in the amount of \$99,000 to allow the California Commission on Disability Access to expend its share of fee revenues collected over fiscal years 2015-16 through 2019-20 pursuant to Government Code section 68085.35. Government Code section 68085.35 was added by Chapter 755, Statutes of 2015 to require that of each \$1,000 high-frequency litigant fee collected pursuant to Government Code section 70616.5, \$500 shall be distributed to the General Fund for use by the Commission, upon appropriation by the Legislature, to supplement the Commission's existing program funding.

It is further requested that provisional language be added to Item 7760-002-0001 as follows:

- 1. Notwithstanding any other law, the funds appropriated in this item shall be available for encumbrance or expenditure until June 30, 2024.
- 2. The Department of Finance may increase this item in the amount of any fee revenues collected during the 2020–21 fiscal year and identified for use by the California Commission on Disability Access pursuant to Section 68085.35 of the Government. Upon augmentation of this item, the Department of Finance shall provide notification in writing to the Chairperson of the Joint Legislative Budget Committee and the chairpersons of the committees in each house of the Legislature, within 30 days of the approval of the augmentation.

Addition of Budget Bill Items 7760-301-0001 and 7760-311-0001, Capital Outlay, Department of General Services

Sacramento Region: Bonderson Building Swing Space—It is requested that Item 7760-301-0001 be added in the amount of \$11,630,000 one-time for design-build authority for improvements to the Paul Bonderson Building in Sacramento (see Attachment 1). These improvements are necessary to prepare the building as swing space for staff from the State Treasurer's Office during the 36 month construction duration of the Jesse Unruh Building Renovation project. The Bonderson project will include corrections to fire and life safety and accessibility deficiencies, removal of hazardous materials, and general office space enhancements. The Bonderson project will be completed by June 2022, when on-site construction activities are scheduled to commence for the Unruh Renovation project.

State Project Infrastructure Fund—It is requested that Item 7760-311-0001 be added in the amount of \$93 million one-time for transfer to the State Project Infrastructure Fund to support the continuation of design and pre-construction activities for the Capitol Annex projects.

Amendment to Various Budget Bill Items and Statutory Changes, Support, California Public Employees' Retirement System

Operational Budget—It is requested that various Budget Bill items be amended to reflect the changes to the fiscal year 2021-22 operational budget of the California Public Employees' Retirement System (CalPERS) that was approved by the CalPERS Board on April 20, 2021. The budget proposed by CalPERS reflects a net increase of \$194,985,000 primarily attributed to external investment management fees, salaries, benefits assumptions, and third party administrator fees. The request is comprised of the following changes:

- Item 7900-003-0830 be increased by \$211,738,000
- Item 7900-015-0815 be increased by \$88,000
- Item 7900-015-0820 be increased by \$32,000
- Item 7900-015-0830 be decreased by \$17,476,000
- Item 7900-015-0833 be increased by \$400,000
- Item 7900-015-0849 be decreased by \$51,000
- Item 7900-015-0884 be increased by \$223,000
- Item 7900-015-9251 be increased by \$31,000

Amendment to Budget Bill Item 7920-011-0001, Support, California State Teachers' Retirement System

It is requested that Item 7920-011-0001 be increased by \$4,917,000 ongoing to reflect an increase in the state's contributions to the California State Teachers' Retirement System's Defined Benefit (DB) Program and Supplemental Benefit Maintenance Account (SBMA), as required in statute. The state's contributions to the DB Program and SBMA are calculated using creditable compensation provided by the Teachers' Retirement Board for the fiscal year immediately preceding June 30. The Board annually publishes a creditable compensation report by October 25, and a subsequent report is due by April 15, that displays necessary revisions to creditable compensation. Based on the Board's April 12, 2021 creditable compensation report, the DB contribution will be increased by \$3,832,000 and the SBMA contribution will be increased by \$1,085,000, as compared to the Governor's Budget.
