Addition of Budget Bill Items 8120-490 and 8120-491, Local Assistance, Commission on Peace Officer Standards and Training

Distance Learning and Use of Force Training Equipment Reappropriation—It is requested that Item 8120-490 be added to extend the encumbrance availability for \$10 million included in the 2018 Budget Act and reappropriated in the 2020 and 2021 Budget Acts by one year, from June 30, 2022 to June 30, 2023 (see Attachment 1). The Commission on Peace Officer Standards and Training (POST) is nearing the final stages of the Project Approval Lifecycle process for its Learning Management System Modernization Project in collaboration with the California Department of Technology, and anticipates a contract will be awarded for this purpose in fiscal year 2022-23.

It is further requested that Item 8120-491 be added to extend the encumbrance availability of \$300,000 included in the 2018 Budget Act and reappropriated in the 2021 Budget Act for use of force and de-escalation training equipment by one year, from June 30, 2022 to June 30, 2023 (see Attachment 2). This will provide an additional year for POST to purchase the necessary equipment to enhance peace officer training.

Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support and Local Assistance, California Department of Food and Agriculture

Information Technology Security Remediation and Sustainability—It is requested that various items be increased by a total of \$3,460,000 and 1 position to provide the Department with resources to manage, implement, and maintain mitigation efforts to resolve information technology security audit findings. These resources will also right-size the Department's personal services, operating expenses, and equipment budgets and fund two existing authorized positions within the Office of Information Technology Services. The request includes the following changes:

- Item 8570-001-0001 be increased by \$2,942,000 and 1 position, and reimbursements be increased by \$26,000
- Item 8570-001-0044 be increased by \$35,000
- Item 8570-001-0111 be increased by \$245,000
- Item 8570-001-0191 be increased by \$6,000
- Item 8570-001-0516 be increased by \$21,000
- Item 8570-001-0890 be increased by \$76,000
- Item 8570-001-3288 be increased by \$4,000
- Appropriation per Food and Agriculture Code section 221 be increased by \$131,000

Emerging Threats Information Data Management System—It is requested that Item 8570-001-0001 be increased by \$1,231,000 and Item 8570-001-0111 be increased by \$723,000 to complete the planning activities required to replace the existing legacy Emerging Threats Information Data Management System for the Animal Health and Food Safety Services Division. Completing these planning activities is essential to establishing a data management system than can effectively provide time-sensitive,

reliable data and reports for daily workload, emergency response, and mitigation of animal disease transmission.

Technical Correction—It is requested that Provision 2(b) of Item 8570-001-6088 be amended to reference Section 80147, rather than Section 81047, of the Public Resources Code (see Attachment 1).

California Farm to School Incubator Grant Program and Healthy Refrigeration Grant Program Evaluations—It is requested that Provisions 1, 3, and 12 of Item 8570-102-0001 be amended authorizing the Department to use funding allocated to the Farm to School Incubator Grant Program and the Healthy Refrigeration Program for support or local assistance (see Attachment 2). This will allow the Department to conduct external program evaluations of these programs, which represent one-time investments that are part of the 2021-22 Sustainable Agriculture Package.

Farm to Community Food Hub Grant Program—It is requested that Item 8570-491 be added to extend the encumbrance period for the Farm to Community Food Hubs Program funding appropriated in the 2021 Budget Act through June 30, 2028 (see Attachment 3). Additionally, it is requested that Item 8570-001-0001 be amended to add 3 positions to implement the requirements of the Farm to Community Food Hubs Program as specified by Chapter 608, Statutes of 2021 (AB 1009).

Extension of Invasive Shot Hole Borer Funding—It is requested that Item 8570-490 be added to extend the liquidation period for funding that supports research and outreach activities related to the invasive shot hole borer until June 30, 2024 (see Attachment 4). Additional time is needed for recipients to liquidate encumbered funds due to the COVID-19 pandemic.

Enterprise Solutions Ongoing Maintenance and Support—It is requested that the followings items be increased by a total of \$5,824,000 in fiscal year 2022-23 and \$6,115,000 ongoing for ongoing maintenance and support costs of enterprise-wide information technology solutions and tools to support various Commission projects and efforts.

Solar Equipment List—It is requested that Item 8660-001-0462 be decreased by \$1,281,000 as part of a request to provide a direct appropriation from the Public Utilities Commission Utilities Reimbursement Account fund for the Energy Resources Conservation and Development Commission's work on the Solar Equipment List. The Solar Equipment List supports the state's utilities and the streamlined approval of interconnection for distributed solar energy resources, storage systems and other technical assistance programs. Funding for this request was originally approved in the 2019 Budget Act for an interagency agreement between the Energy Resources Conservation and Development Commission and the California Public Utilities Commission. Providing a direct appropriation simplifies the funding mechanism, which reduces the administrative burden on both entities.

Intervenor Compensation Program—It is requested that the following items be increased by a total of \$866,000 in 2022-23 and 2023-24, and \$651,000 ongoing for 4.8 positions within the Administrative Law Judge Division for the Intervenor Compensation Program. Departmental Onboarding and California State Payroll System Adjustment—It is requested that Item 8880-001-0001 be increased by \$9,066,000 and 3 positions ongoing and Item 8880-001-9740 be increased by \$6,045,000 and 2 positions ongoing to provide the resources necessary to onboard the Department of Technology and the Department of Rehabilitation to the Financial Information System for California (FI\$Cal); begin planning for onboarding the Department of Transportation; and interface FI\$Cal with the California State Payroll System (CSPS).

It is requested that Item 8880-011-0001 be added in the amount of \$5,530,000 and Item 8880-011-9740 be added in the amount of \$3,686,000 to provide additional resources, if necessary, for FI\$Cal interfaces to CSPS. This includes positions such as custodians, groundskeepers, and electricians, as well as necessary equipment such as work vehicles and maintenance supplies. This request is important to oversee daily maintenance and conduct timely repairs at the Headquarters, and to perform a variety of skilled work in the operation, maintenance and repair of critical elements of the property such as electrical, plumbing, heating, lighting, air conditioning, and ventilating.
