Amendment to Budget Bill Items 7120-001-0001 and 7120-001-3228, Support, and Addition of Item 7120-490, Local Assistance, California Workforce Development Board

Technical Adjustment: Position Authority—It is requested that Item 7120-001-0001 be increased by 30 positions ongoing to support the California Workforce Development Board in addressing its existing and future workload.

AB 680 Implementation Resources—It is requested that Item 7120-001-3228 be increased by \$160,000 and 1 position ongoing to implement Chapter 746, Statutes of 2021 (AB 680). This request modifies the request in the Governor's Budget to include a position to implement this legislation that was inadvertently not included in the Governor's Budget.

Social Entrepreneurs for Economic Development Liquidation Extension—It is requested that Item 7120-490 be added to extend the liquidation period from June 30, 2022 to June 30, 2023 for the Social Entrepreneurs for Economic Development (SEED) program funding provided in the 2020 Budget Act (see Attachment 1). This extension will allow grantees time to complete implementation of the program.
