Amendment to Budget Bill Item 0250-001-0001, Support, Judicial Branch

San Diego Hall of Justice Facility Modification—It is requested that Item 0250-001-0001 be increased by \$27.1 million one-time for a facility modification project in the San Diego County Superior Court's Hall of Justice. The Judicial Council is responsible for 40 percent of this facility's costs, pursuant to a Joint Occupancy Agreement. These resources will cover the Judicial Council's costs to complete the facility modification project, specifically to repair existing elevators, escalators, and the air conditioning system. It is also requested that provisional language be added to extend encumbrance or expenditure availability until June 30, 2025 (see Attachment 1).

East County Regional Center Facility Modification—It is requested that Item 0250-001-0001 be increased by \$13,550,000 one-time to address egress deficiencies identified by the State Fire Marshal in the East County Regional Center of the San Diego County Superior Court. These resources are necessary to make critical repairs and allow the facility to retain its Certificate of Occupancy.

Addition of Budget Bill Item 0280-490, Support, Commission on Judicial Performance

It is requested that Item 0280-490 be added to reappropriate up to \$200,000 of Item 0280-001-0001, Budget Act of 2021, with funding available for encumbrance and expenditure until June 30, 2023. Chapter 79, Statutes of 2021 (AB 143) established a 15-member committee to review the operations and structure of the Commission on Judicial Performance and to develop recommendations that would improve the Commission's ability to carry out its core responsibilities. AB 143 also required the Governor and Legislature, among others, to appoint members to this committee. Because the majority of the committee was just recently appointed, the Commission will be unable to encumber funding by June 30, 2022. This reappropriation is necessary to cover the costs of the committee in 2022-23 and provide additional time for the committee to complete its required work (see Attachment 1).

Amendment to Various Budget Bill Items, Support, California State Transportation Agency

California Office of Traffic Safety Program Planning and Outreach—It is requested that various items be increased by a total of \$2,290,000 in fiscal year 2022-23 and \$1,650,000 and 10 positions ongoing beginning in 2023-24 to expand the California Transportation Agency's Office of Traffic Safety. Resources will be used to provide outreach and technical assistance to existing and prospective grantees for delivery of federal traffic safety funding. Additionally, funding will be used for one-time office reconfiguration costs to support the new positions and transition to a hybrid workforce.

Specifically, this request includes the following adjustments:

Amendment to Budget Bill Items 0530-001-0001, 0530-001-3377 and Reimbursements, and Addition of Items 0530-490 and 0530-491, Support, Secretary for California Health and Human Services Agency (CalHHS)

Office of Resilience and Response (Issue 033)—It is requested that Item 0530-001-0001 be increased by \$2,593,000 annually over three years and authority for 9 permanent positions to conduct planning, policymaking, coordinating activities, and resources to provide oversight and leverage the All-Hazards Dashboard.

Equity Implementation (Issue 035)—It is requested that Item 0530-001-0001 be increased by \$500,000 one-time to develop an agency-wide equity strategic plan with documented goals and objectives.

Office of the Agency Information Officer and Office of Systems Integration – Enterprise Capabilities (Issue 039)—It is requested that Item 0530-001-0001 be increased by \$2,889,000 in fiscal year 2022-23 and \$2,489,000 in 2023-24 and ongoing to support 8 positions and contracts to develop enterprise-wide capabilities across the Agency. This would improve project delivery outcomes, and provide technical capabilities in support of CaIHHS' priorities.

Center for Data Insights and Innovations (CDII) Reimbursements (Issue 042)—It is requested that Item 0530-001-3377 be amended by increasing reimbursements by \$600,000 and decreasing Item 0530-001-3377 by \$443,000 ongoing. This adjustment allows CalHHS to conduct interagency agreements with six other HHS departments (Department of Social Services, Department of Developmental Services, Department of State Hospitals, Department of Health Care Access and Information, Department of Public Health, and Department of Health Care Services) for CDII expenses related to salary and operating expenses necessary for the maintenance of the Committee for the Protection of Human Subjects. Children and Youth Behavioral Health Initiative: Public Education and Change Reappropriation (Issue 045)—It is requested that Item 0530-490 be added to reappropriate up to \$25 million from Item 0530-001-0001 of the 2021 Budget Act to support the Adverse Childhood Experience Awareness Campaign and Trauma-Informed Training for Educators through June 30, 2025 (see Attachment 1).

Equity Dashboard Reappropriation (Issue 046)—It is requested that Item 0530-491 be added to reappropriate up to \$3,172,000 from Item 0530-001-0001 of the 2021 Budget Act, through June 30, 2023, for activities to establish an equity dashboard, which shall be informed by the annual California Department of Public Health reporting on health disparities adopted by the Legislature as part of public health infrastructure investments (see Attachment 2).

Children and Youth Behavioral Health Initiative: Subject Matter Expertise and Evaluation—It is requested provisional language be added to Item 0530-001-0001 to provide flexibility for CaIHHS to fully expend funds approved as part of the 2021 Budget Act. The 2021 Budget Act allocated \$50 million General Fund over five years for CaIHHS to provide subject matter expertise and evaluation for the Children and Youth Behavioral Health Initiative. Of this amount, \$10 million was budgeted in 2021-22. The requested provisional language extends the availability for encumbrance or expenditure for the remaining \$40 million to allow for activities to continue without interruption through June 30, 2026 (see Attachment 3).

Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support, Local Assistance, and Capital Outlay, Various Departments within the Natural Resources Agency

This proposal includes requests for various adjustments to continue implementation of previously authorized programs and projects. A comprehensive list of the requested attachments is available upon request.

California Natural Resources Agency, Various Adjustments, Reappropriations, and Extensions of Liquidation—It is requested that provisional language be added to Item 0540-001-0001 to authorize funds included in the Governor's Budget to be used for state operations or local assistance (see Attachment 1).

It is also requested that Item 0540-001-6031 be decreased by \$86,000, Item 0540-001-6051 be decreased by \$2,758,000, Item 0540-001-6083 be increased by \$213,000, and Item 0540-001-6088 be decreased by \$182,000 ongoing to reflect economies of scale, extend implementation timelines, and increase bond reconciliation and oversight efforts across various bond funds.

It is also requested that Item 0540-490 be amended to reappropriate the balances of funds from Item 0540-101-0001, Budget Act of 2018, and Item 0540-101-0001, Budget Act of 2019, with funding available for encumbrance or expenditure until June 30, 2025 (see Attachment 2). This will provide additional time for project completion and the funding to be spent for the same purposes for which the funds were originally appropriated.

It is further requested that Item 0540-492 be added to extend the liquidation periods for various state operations and local assistance appropriations, to June 30, 2023 (see Attachment 3).

Exposition Park, Reappropriation—It is requested that Item 3100-490 be added to reappropriate the balances of funds available for the Phase I ADA Elevator Addition project. This reappropriation is necessary to allow the California Science Center additional time for completion of the project consistent with the purpose for which funds were initially appropriated (see Attachment 4).

California Conservation Corps—It is requested that Item 3340-490 be amended to remove a reappropriation that is no longer needed (see Attachment 5).

State Energy Resources Conservation and Development Commission, Reappropriations and Extensions of Liquidation—It is requested that Item 3360-491 be added to reappropriate the balances of funds from various state operations and local assistance appropriations, with funding available for encumbrance or expenditure until June 30, 2023 and June 30, 2024 (see Attachment 6). These reappropriations are needed to allow the Commission to address potential delays from COVID-19. This will provide additional time for project completion and the funding to be spent for the same purposes for which the funds were originally appropriated.

It is also requested that Item 3360-492 be added to extend the liquidation periods for various state operations and local assistance appropriations (see Attachment 7). This extension is needed to allow the Commission to address potential delays from COVID-19. This will provide additional time for project completion and the funding to be spent for the same purposes for which the funds were originally appropriated.

Department of Conservation, Increase in Reimbursement Authority, Federal Trust Fund Authority, and Reappropriation—It is requested that Item 3480-001-0338 be amended by adding \$1,817,000 reimbursements ongoing to contribute geologic expertise to various statewide efforts. It is also requested that Item 3480-001-0890 be increased by \$700,000 one-time to allow the Department to implement a contract with the United States Forest Service to develop end-user tools. It is further requested that Item 3480-492 be added to reappropriate the balances of funds from Item 3480-101-0001, Budget Act of 2021, which was inadvertently missing a provision to allow up to 5 percent to be utilized for administrative costs (see Attachment 8).

It is also requested that Item 3540-492 be added to reappropriate specified balances from Item 3540-005-3228, Budget Act of 2019 until June 30, 2023, which will allow for maintenance of evacuation routes to assist communities in preparing for wildfire, and for block grants to county groups to support the implementation of fire prevention, which were delayed due to COVID-19 (see Attachment 10). It is further requested that Item 3540-495 be added to revert the Growlersburg Conservation Camp: Replace Facility project (see Attachment 11).

Wildlife Conservation Board, Extension of Liquidation and Various Adjustments—It is requested that Item 3640-301-6031 be amended to display the correct program (see Attachment 12). It is also requested that Item 3640-301-6088 be added in the

amount of \$5,550,000 one-time and Item 3640-302-6029 be added in the amount of \$172,000 one-time for projects for the San Joaquin River Conservancy Propositions 68 and 40 programs. It is also requested that provisional language be added to make funds available for encumbrance or expenditure until June 30, 2025 (see Attachments 13 and 14). It is further requested that Item 3640-491 be added to extend the liquidation period of Item 3640-101-0001, Budget Act of 2018, to June 30, 2025, due to project delays (see Attachment 15).

State Coastal Conservancy, Appropriations of Proposition 40—It is requested that Item 3760-101-6029 be added in the amount of \$2,359,000 one-time to protect and restore coastal and bay resources and promote public access to the coast and San Francisco bay shoreline (see Attachment 16).

Department of Parks and Recreation, Various Bond Administrative Adjustments—It is requested that Item 3790-001-6029 be increased by \$67,000 annually for three years, Item 3790-001-6051 be increased by \$160,000 annually for four years, Item 3790-001-6088 be increased by \$60,000 annually for three years, and Item 3790-002-6088 be increased by \$200,000 one-time to provide additional bond administration funding to address increasing workload needs of bond programs.

Sacramento-San Joaquin Delta Conservancy, Reversions and Technical Adjustments—It is requested that Item 3875-101-6083 be increased by \$542,000 to continue support of planning and implementation of projects. It is also requested that Item 3875-495 be

amended to modify the dollar amount and correct the item number of an existing reversion necessary to facilitate project delivery (see Attachment 32).

Administrative Resources for California State Payroll System Project--It is requested that Item 0840-001-0001 be increased by \$379,000 to provide limited term funding for 2 positions in fiscal year 2022-23 and \$372,000 in 2023-24 through 2025-26 to support increased administrative workload associated with the California State Payroll System (CSPS) Project.

It is further requested that provisional language be added to Item 0840-001-0001 to conform to this action:

18. Notwithstanding any other law, of the amount appropriated in this item, \$379,000 in 2022-23 is provided to support the administration of the California State Payroll System Project. The Department of Finance, in consultation with the State Controller's Office, will reevaluate these resources after the 2025-26 fiscal year.

Unclaimed Property Management System Replacement--It is requested that Item 0840-001-0970 be increased by \$323,000 in fiscal year 2022-23, \$1,183,000 in 2023-24, \$1,647,000 in 2024-25, \$1,685,000 in 2025-26, and \$1,724,000 in 2026-27 and ongoing to support the replacement of the current unclaimed property management system as it nears the end of its useful life.

California State Employees Telework and Health Care Stipends—-It is requested that Item 0840-001-0001 be increased by \$297,000 in fiscal year 2022-23, \$116,000 in 2023-24 and ongoing, and Item 0840-001-9740 be increased by \$198,000 in 2022-23, \$78,000 in 2023-24 and ongoing to support the processing and disbursement of the bargained Telework and Healthcare stipends. **Technical Adjustment to California State Payroll System Project** –-It is requested that Item 0840-001-0001 be increased by \$39,138,000 and 12.8 positions in fiscal year 2022-23, \$2,719,000 in 2023-24, \$2,662,000 in 2024-25, and \$2,661,000 in 2025-26 and ongoing, and Item 0840-001-9740 be decreased by \$39,138,000 and 12.8 positions in 2022-23, \$2,719,000 in 2023-24, \$2,662,000 in 2024-25, and \$2,661,000 in 2025-26 and ongoing. Notwithstanding any other law, \$49,950,000 \$83,250,000 of the amount included in this item and \$33,300,000 of the amount included in Item 0840 001 9740 for California State Payroll System Project future solution costs shall be allocated upon order of the Department of Finance. Stage 4 of the Project Approval Lifecycle Process must be approved by the California Department of Technology prior to these funds being made available. Allocation of these funds will be made after a 30 day notification in writing to the chairpersons of the budget committees in both houses of the Legislature and, the Joint Legislative Budget Committee, and the appropriate subcommittees in both houses of the Legislature."
