- "7381. (a) Revenue received pursuant to Section 7380 may be expended, upon appropriation by the Legislature, only to monitor, restore, or enhance steelhead trout resources consistent with Sections 6901 and 6902, and to administer the fishing report-restoration card program. The department shall submit all proposed expenditures, including proposed expenditures for administrative purposes, to the Advisory Committee on Salmon and Steelhead Trout for review and comment before submitting a request for inclusion of the appropriation in the annual Budget Bill. The committee may recommend revisions in any proposed expenditure to the Legislature and the commission.
- (b) The department shall report to the Legislature on or before July 1, 2026,2021, regarding the steelhead trout fishing report-restoration card program's projects undertaken using revenues derived pursuant to that program, the benefits derived, and its recommendations for revising the fishing report-restoration card requirement, if any. The report submitted pursuant to this subdivision shall be submitted in compliance with Section 9795 of the Government Code.

7382. This article shall become inoperative on <u>January 1, 2028</u>, <u>July 1, 2022</u>, and, as of <u>July 1, 2028</u>, <u>January 1, 2023</u>, is repealed, unless a later enacted statute that is enacted before <u>July 1, 2028</u>, <u>January 1, 2023</u>, deletes or extends the dates on which it becomes inoperative and is repealed."

Tamarack Wildfire Repair—It is requested that Item 3790-002-0001 be increased by \$5 million General Fund one-time for the Tamarack Wildfire Repair project in Grover Hot Springs State Parks. This request will allow the Department to replace and repair lost equipment and destroyed facilities, and will provide for the restoration of the trails back to pre-disaster condition. preliminary plans and working drawings phase of the project and Schedule (1) of Item 3790-301-0263 be eliminated (see Attachment 3). This request will shift the fund source for the project from the Off-Highway Vehicle Trust Fund to the General Fund.

Kings Beach State Recreation Area (SRA): Recreational Pier Replacement and Support Buildings—It is requested that Item 3790-301-0392 be added to provide \$805,000 in reimbursements one-time for the preliminary plans phase of the Kings Beach SRA: Recreational Pier Replacement and Support buildings project in Placer County.
