## California Current Population Survey Report: March 2001 Data

The Current Population Survey (CPS) is conducted monthly by the U.S. Bureau of the Census for the Bureau of Labor Statistics. Although its main purpose is to collect information used to produce employment statistics, an important secondary purpose is to collect information on the demographic and economic status of the population. This is accomplished through supplemental questions in the March survey. The CPS targets a sample of almost 50,000 civilian non-institutional households in the U.S., of which about 4,400 are in California.

## **ESTIMATION PROCEDURE**

The survey's estimation procedure inflates sample-weighted results to independent national estimates of the civilian non-institutional population by age, sex, race, and Hispanic origin. There are no state-specific controls for the sample. Due to the unique sample design and weighting procedures used in the March Supplement of the CPS, the population estimate for the state is not consistent with current population estimates produced by either the U.S. Census Bureau or the California Department of Finance.

Race/ethnicity tables were constructed using mutually exclusive categories. The response to the Hispanic origin question took priority when determining race/ethnicity. The resulting categories are: non-Hispanic White, Black, Asian/Pacific Islander, Other; and Hispanic.

## **COMPARABILITY OF CPS ESTIMATES**

Estimates for a given year, particularly 1994 and 1995, may differ from earlier years by more than can be attributed to real changes in population characteristics. The use of summary measures, such as means, medians, and percentages, is recommended.

The CPS estimate of California's total population is volatile, and frequently inconsistent with other estimates. For example, the CPS estimate for 1995 is less than the estimate for 1994. Other estimates for the state, such as the Census Bureau or the Department of Finance (DOF), show growth during that period. The March 2001 CPS estimate of 34,735,000 is 83,000 lower than the official Department of Finance January 1, 2001, estimate of 34,818,000. In most years, the divergence between the two sources is much larger<sup>3</sup>.

<sup>&</sup>lt;sup>3</sup>Strictly speaking, the CPS and DOF estimates should not be expected to be the same. The CPS estimate is for the civilian non-institutional population (and also includes military personnel living off-base or in civilian housing on-base), while the DOF estimate is for the entire resident population of the state.

## **DATA LIMITATIONS**

All estimates developed from the CPS are subject to sampling error. The magnitude of the error is inversely related to the size of the population being estimated. Estimates for the nation are better than estimates for the state. Estimates for a large segment of the state (e.g., total employed) are better than for a smaller segment (e.g., employment in retail trade). Differences in an estimate over time may be due to sampling error rather than actual change. Data items with broad confidence intervals indicate large sampling errors. Estimates of 100,000 or less have large standard errors and are denoted with *italic* type.

Numbers of persons, families, and households are rounded to the nearest thousand. Dollar amounts are rounded to the nearest hundred. All percentages are calculated on the unrounded numbers.

## Individual components may not sum up to totals because of independent rounding.

To assist in determining the size of the sampling error for an estimate, 90 percent confidence intervals were calculated for selected data items and included in Appendix A.


#### I. Persons -- General Population Characteristics




#### Figure 1. Population Shares by Race/Ethnicity




Figure 3. Distribution of Persons (15+) by Sex and Marital Status


The proportion of the population living below the poverty threshold varies widely by race/ethnicity, and also by age. According to the March 2001 CPS, among the 50 states and the District of Columbia, California had the 12th highest proportion of population in poverty. Mean personal income in 2000 for persons 15 and older in California was up 9 percent over the preceding year.




Figure 5. Percentage of Persons Below Poverty Level by Age

#### **III. Persons -- Health and Health Insurance**

Based on self-reporting, most Californians are relatively healthy. Of all persons 21 and over, 86 percent believe that they are in good to excellent health. This is despite the fact that 18 percent of the population is not covered by any health insurance. Most noticeable, persons 18 to 34 are more likely to be uninsured than any other age group.

#### **IV. Persons -- Educational Attainment**

Although the average Californian aged 25 and over has 1 year of college, a significant number (4 million) have less than a high school diploma. Of the 4 million with less than a high school education, 2.6 million are foreign born. The importance of education is reflected in median personal income. On average, personal income increases steadily with educational attainment. The median personal income increases from \$18,900 for a high school graduate to \$38,200 for a person with a BA/BS degree to \$55,200 for a person with a Master's degree or higher.





Figure 6. Distribution of Persons (25+) by Race/Ethnicity and Educational Attainment





Table 19. Median Personal Income by Educational Attainment and Race/Ethnicity for Persons (25+), 2000





#### Figure 8. Median Personal Income (2000) for Persons (25+) by Educational Attainment and Race/Ethnicity

Figure 10. Percent of Persons (25+) by Age Group and Sex with a BA/BS or Higher








Figure 12. Distribution of Persons (Foreign-Born) by Age and Sex

#### VI. Persons -- Mobility

According to CPS estimates, a greater number of persons annually leave California for other states than enter California from another state. While these estimates are not consistent with other sources of domestic migration, the outward migration trend suggested by CPS data has been consistent throughout the decade. The CPS also found that 16 percent of all persons age 1 or older had lived in their current residence less than one year, and that nearly two-thirds of these movers had come from elsewhere within the same county.




Figure 13. Persons (16+) by Age, Labor Force Participation Rate, and Sex




Figure 14. Unemployment Rates\* by Race/Ethnicity and Sex


#### **VIII.** Persons -- Household Characteristics


#### IX. Households and Families -- Size and Structure


#### X. Households and Families -- Economic Characteristics

Of the 684,000 families below poverty with children, 42 percent are single-parent families with a female head. Of the nearly 1.4 million single-parent families with children, 26 percent of them live below the poverty threshold. Two-worker families outnumber one-worker families. The median family income for families headed by Whites is the largest, at \$65,100, trailed very closely by those headed by Asians or Pacific Islanders, at \$63,000. In contrast, the median family incomes for Blacks and Hispanics are much lower, at \$41,700 and \$35,000 respectively.

#### Figure 17. Distribution of Family Types with Children by Poverty Status




Figure 18: Distribution of Families in Poverty with Children by Family Type




Figure 19. Median Family Income by Race/Ethnicity of Householder

## Appendix B: Major Changes in the Current Population Survey since 1985

**2001**: The Census Bureau will expand the sample size to improve state estimates of children's health insurance coverage in the winter of 2001-02. This data is to be released in autumn of 2002. The original September 2001 sample file was revised due to a weight adjustment\*. This report contains only data from the original revised sample file released December 2001.

**1996**: The sample size taken in Los Angeles County was significantly reduced. The March survey for the first time contained a question on self-reported health status of the respondents.

**1994**: The independent national population controls used for age, sex, race, and Hispanic origin were prepared by projecting forward the population as enumerated in the 1990 decennial census adjusted for the 1990 census undercount. Most estimates in the profile were affected by these changes.

1990: The sample reduction from 1989 was restored.

**1989:** The sample size for California was reduced by approximately 38 percent.

**1985**: Controls for the Hispanic population were introduced for the first time. These controls included an estimate of illegal immigrants.
