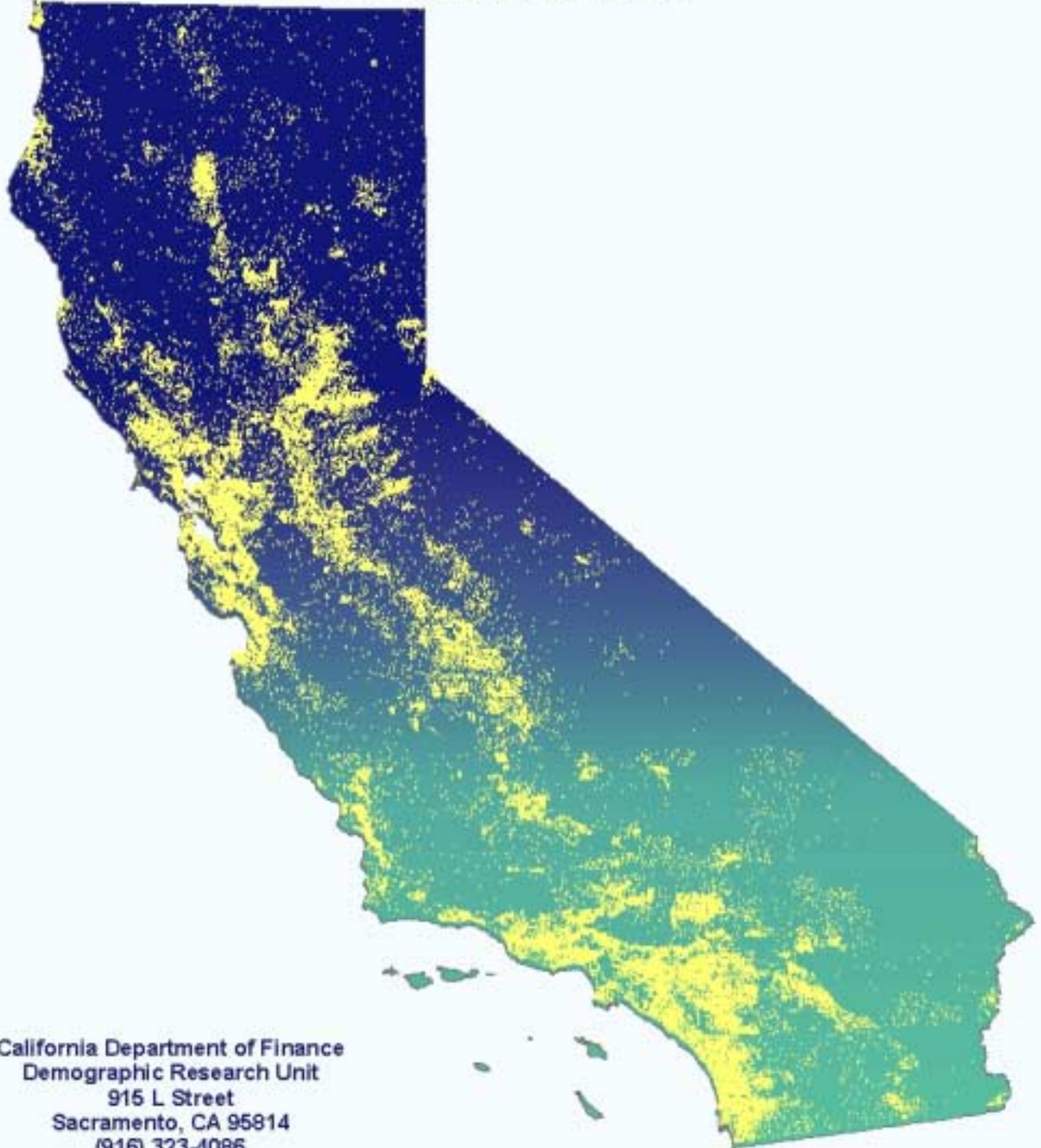

CALIFORNIA CURRENT POPULATION SURVEY REPORT: MARCH 2002 DATA

The Current Population Survey (CPS) is conducted monthly by the U.S. Census Bureau for the Bureau of Labor Statistics. Although its main purpose is to collect information used to produce employment statistics, an important secondary purpose is to collect information on the demographic and economic status of the population. This is accomplished through supplemental questions in the March survey. The CPS targets a sample of almost 50,000 civilian non-institutional households in the U.S., of which about 5,600 are in California.

DATA LIMITATIONS

The survey's estimation procedure uses independent samples for each state and inflates sample-weighted results to independent national estimates of the civilian non-institutional population by age, sex, race, and Hispanic origin. Due to the unique sample design and weighting procedures used in the March Supplement of the CPS, the population estimate for the state is not consistent with current population estimates produced by either the U.S. Census Bureau or the California Department of Finance.¹

As the primary purpose of the CPS is to gather labor force data, the sampling procedure used to determine the size of the survey is based on the Coefficient of Variation (CV) of the level of unemployment. This procedure ensures the allocation of a sufficient sample required to maintain a certain level of CV on national monthly estimates of the unemployment level and unemployment rate. However, it definitely limits the reliability of demographic information such as age, sex, race/ethnicity and other variables which are closely correlated with the labor force variables. All estimates developed from the CPS are subject to sampling error. The magnitude of the error is inversely related to the size of the population being estimated. Estimates for the nation are better than estimates for the state. Estimates for a large segment of the state (e.g., total employed) are better than for a smaller segment (e.g., employment in retail trade). Differences in an estimate over time may be due to sampling error rather than actual change. Data items with broad confidence intervals indicate large sampling errors. ***Estimates of 100,000 or less have large standard errors and are denoted with italic type.***

Estimates for a given year, particularly 1994 and 1995, may differ from earlier years by more than can be attributed to real changes in population characteristics. 2002 is the first year to use population controls from the 2000 census. From 1994 to 2001, population controls were based on 1990 census data making comparability to 2002 and subsequent years difficult. According to the Census Bureau, differences could be disproportionately greater for certain subpopulation groups than for the total populations. The use of summary measures—such as means, medians, and percentages—is recommended.

¹The CPS and DOF estimates should not be expected to be the same. The CPS estimate is for the civilian non-institutional population (and also includes military personnel living off-base or in civilian housing on-base), while the DOF estimate is for the entire resident population of the state.

USER'S NOTE

Race/ethnicity tables were constructed using mutually exclusive categories. The response to the Hispanic origin question took priority when determining race/ethnicity resulting in Hispanic and non-Hispanic categories. The non-Hispanic categories are: White, Black, Asian/Pacific Islander, and Other. The Hispanic category includes persons of Latino origin and can be of any race.

Numbers of persons, families, and households are rounded to the nearest thousand. Dollar amounts are rounded to the nearest hundred. All percentages are calculated on the unrounded numbers.

Individual components may not sum up to totals because of independent rounding.

To assist in determining the size of the sampling error for an estimate, 90 percent confidence intervals were calculated for selected data items and included in Appendix A.

Figure 1. Population Shares by Race/Ethnicity

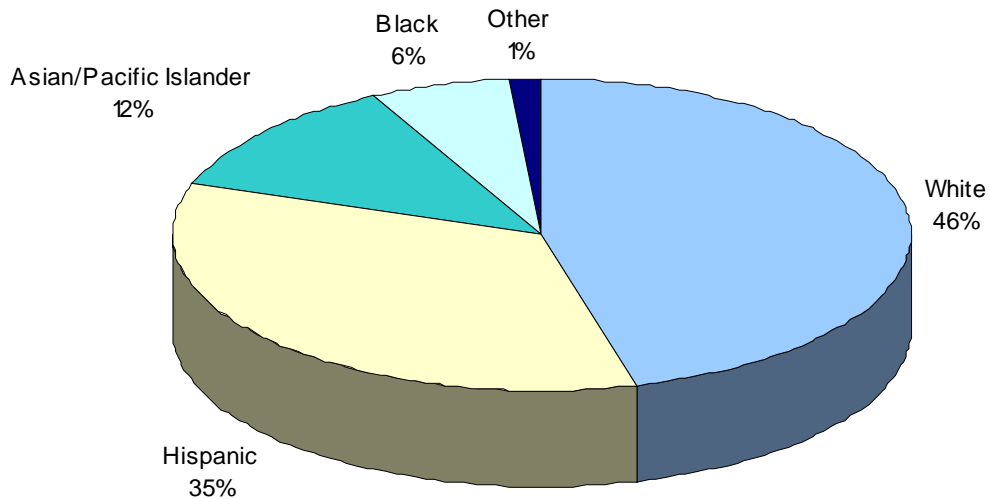

Figure 2. Median Age by Race/Ethnicity and Sex

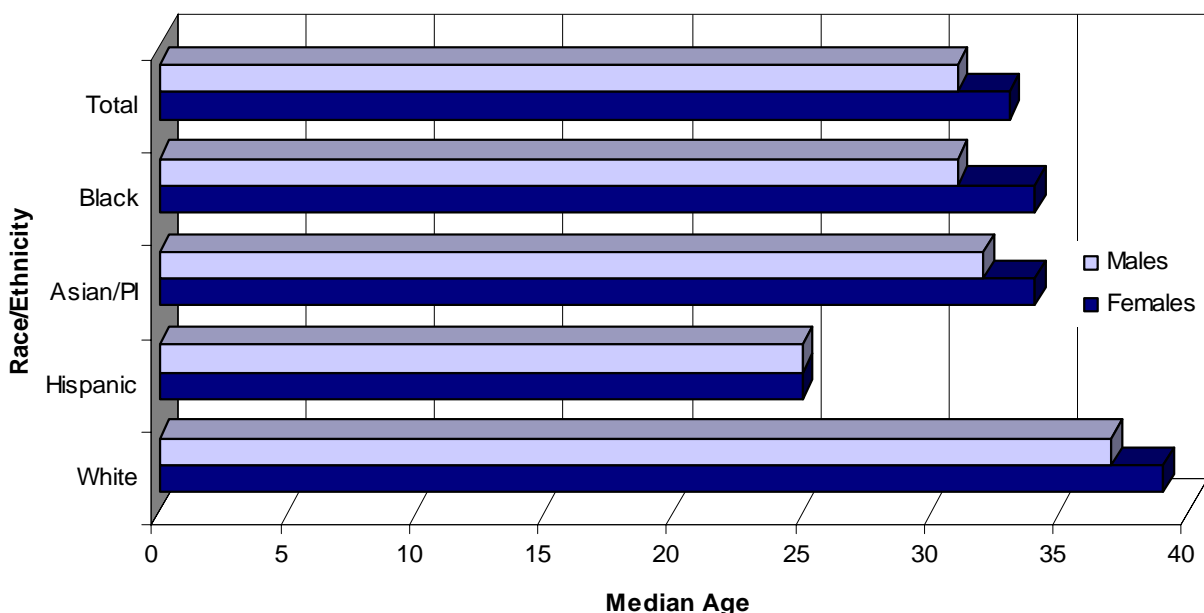

Figure 3. Distribution of Persons (15+) by Marital Status and Sex

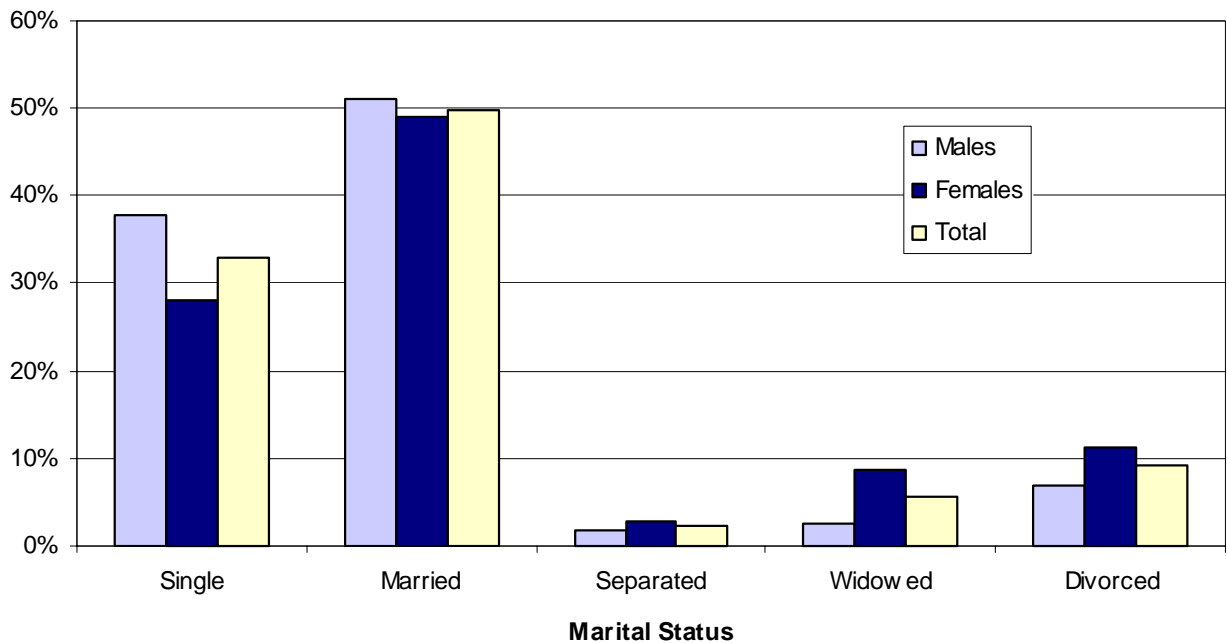

II. Persons — Poverty and Income

The proportion of the population living below the poverty threshold varies widely by race/ethnicity and by age. Whites had the lowest proportion (7.8 percent) below poverty while Hispanics had the highest proportion (20.1 percent). The poverty rate was highest for persons age 17 and younger (35.1 percent) and lowest for those age 65 and over (8.5 percent). For males age 15 and older in California, mean personal income in 2001 was down by about 4.4 percent over the preceding year while for females age 15 and older mean personal income was up by about 4.4 percent.

Figure 4. Percentage of Persons Below Poverty Level by Race/Ethnicity

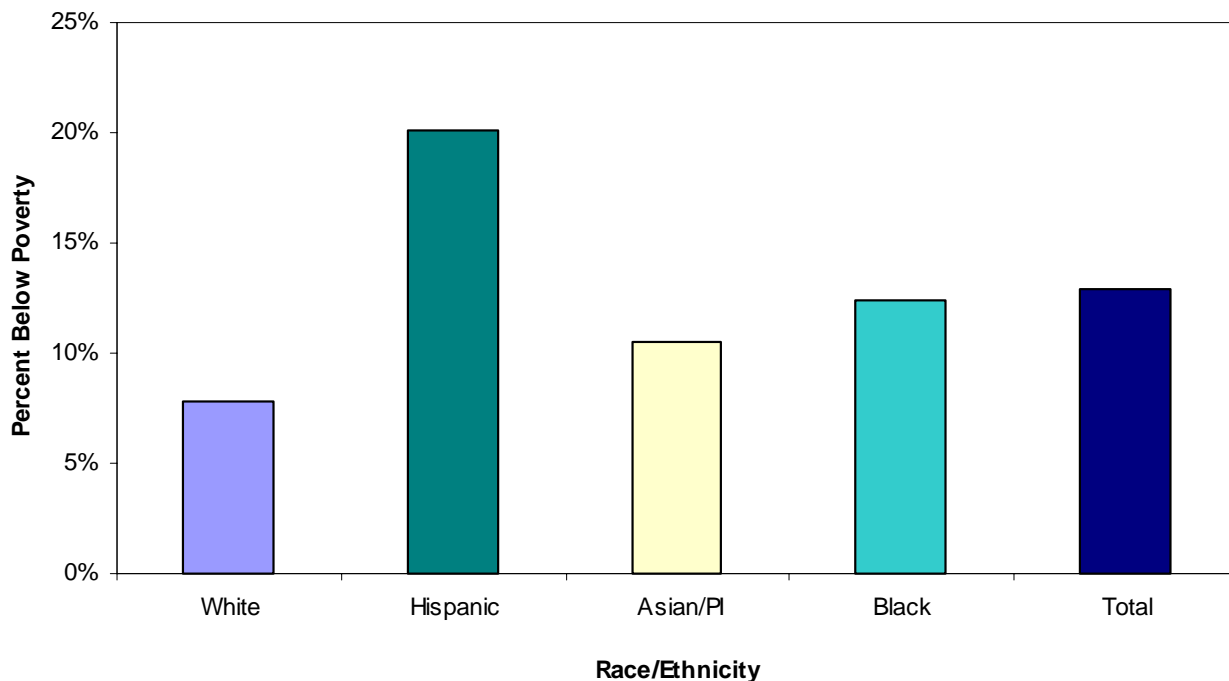

Figure 5. Percentage of Persons Below Poverty Level (2001) by Age and Sex

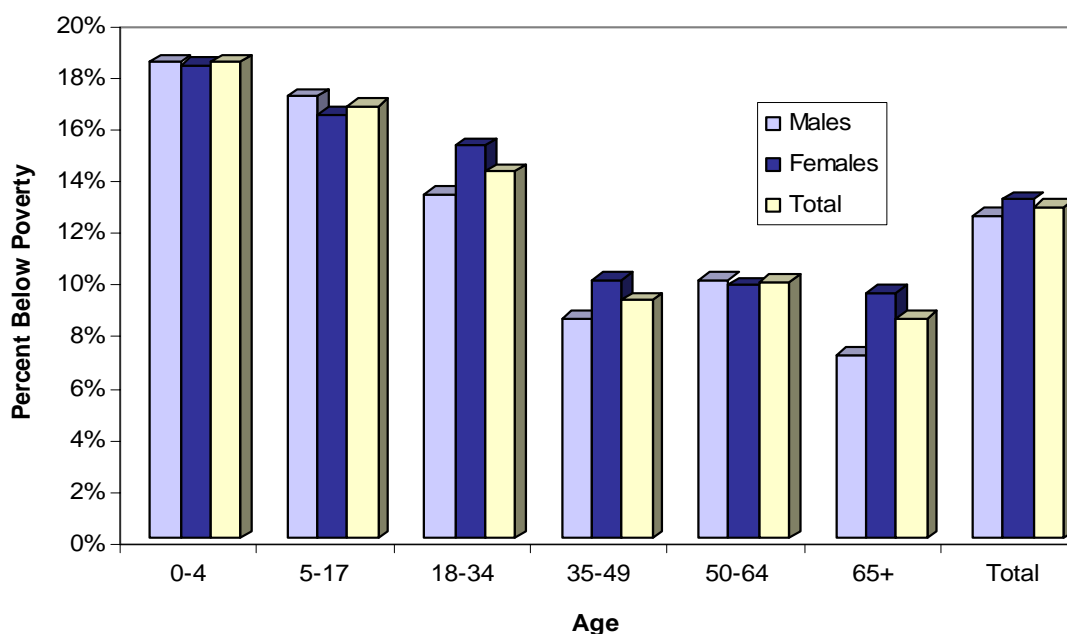

III. Persons — Health and Health Insurance

When asked to appraise their health, 86.5 percent of Californians age 21 and over report that they are in good to excellent health. However, 19.5 percent of the state's total population is not covered by health insurance. Persons age 18 to 34 were more likely to be uninsured than any other age group while less than 2 percent of those age 65 and older lack health insurance of some kind.

IV. Persons — Educational Attainment

High school graduates and persons with some college or an AA degree make up over half of all Californians age 25 and older. A significant number of the state's residents (4.1 million) have less than a high school diploma, of which 2.9 million are foreign-born. Higher educational attainment is generally reflected in higher levels of median personal income. Median personal income increases from \$18,400 for a high school graduate, to \$40,100 for a Bachelor's degree, to \$55,500 for a Master's degree or higher.

Figure 6. Distribution of Persons (25+) by Race/Ethnicity and Educational Attainment

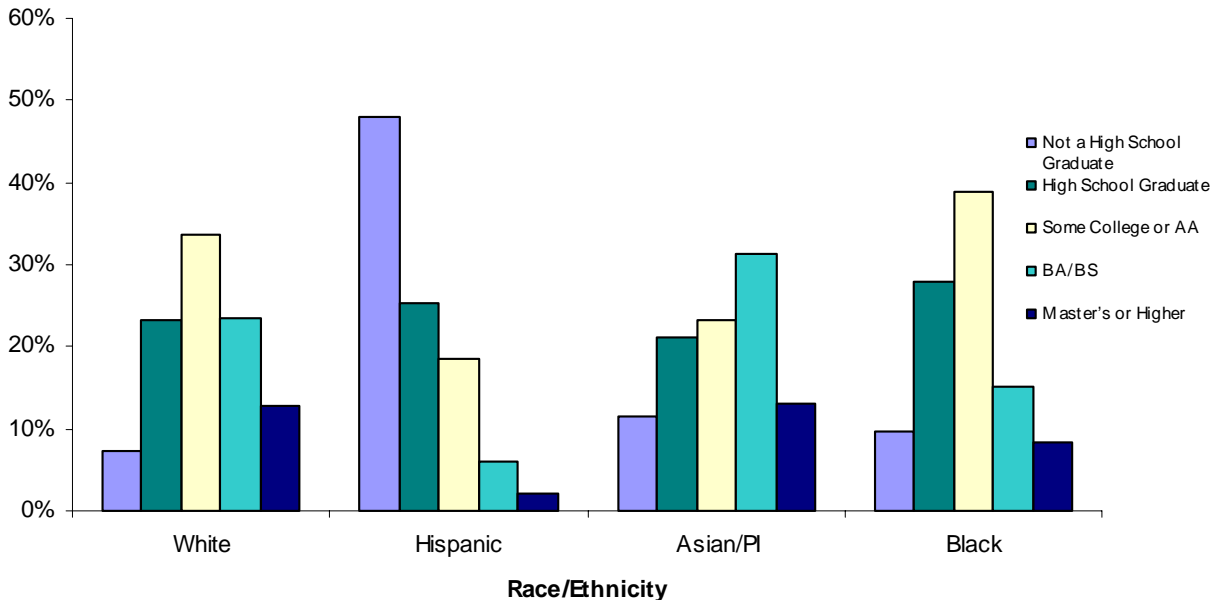

Figure 7. Distribution of Persons (25+) by Nativity and Educational Attainment

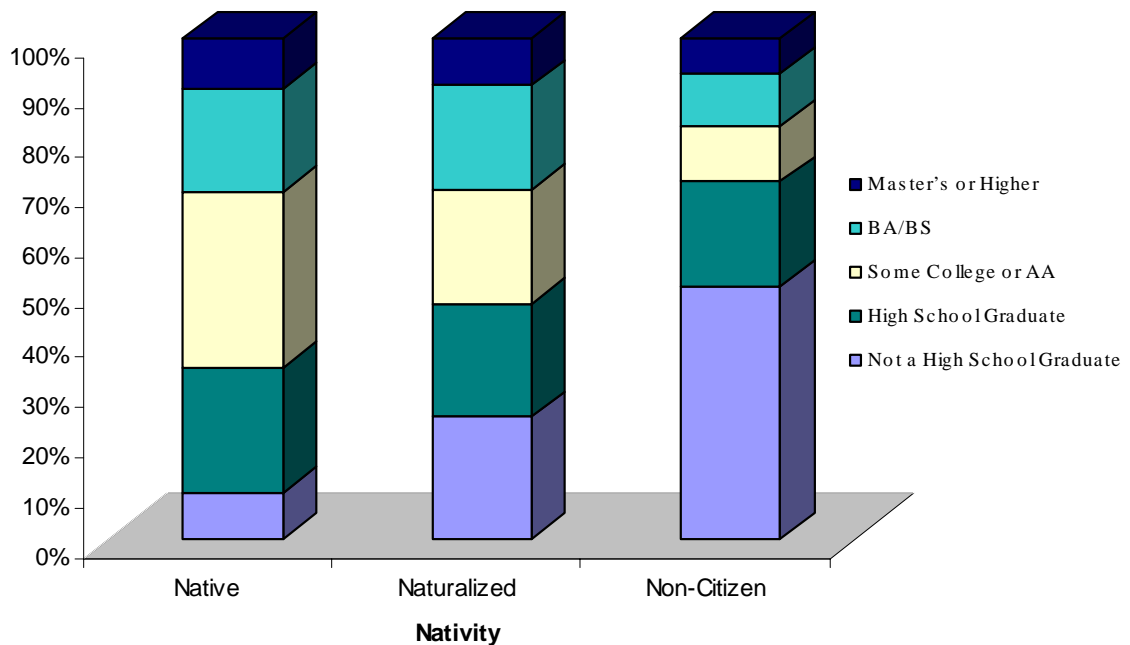

Figure 8. Median Personal Income (2001) for Persons (25+) by Educational Attainment and Race/Ethnicity

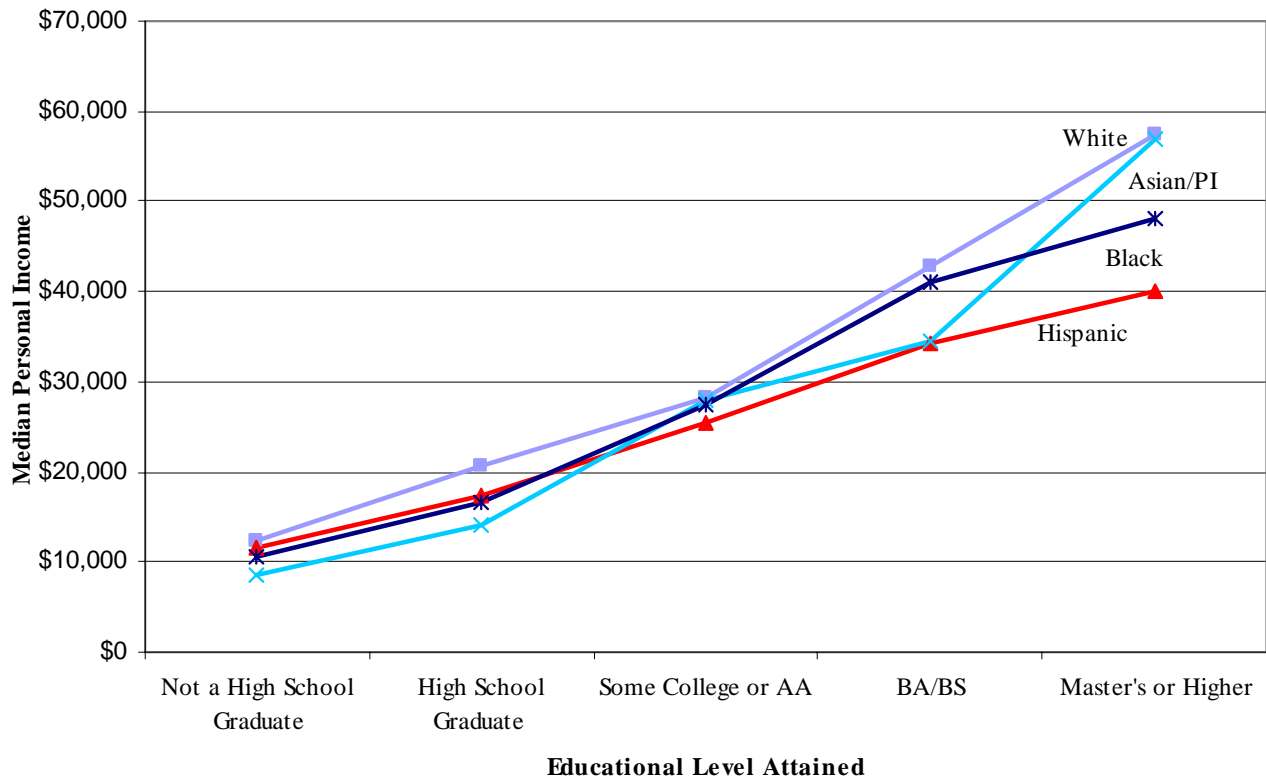
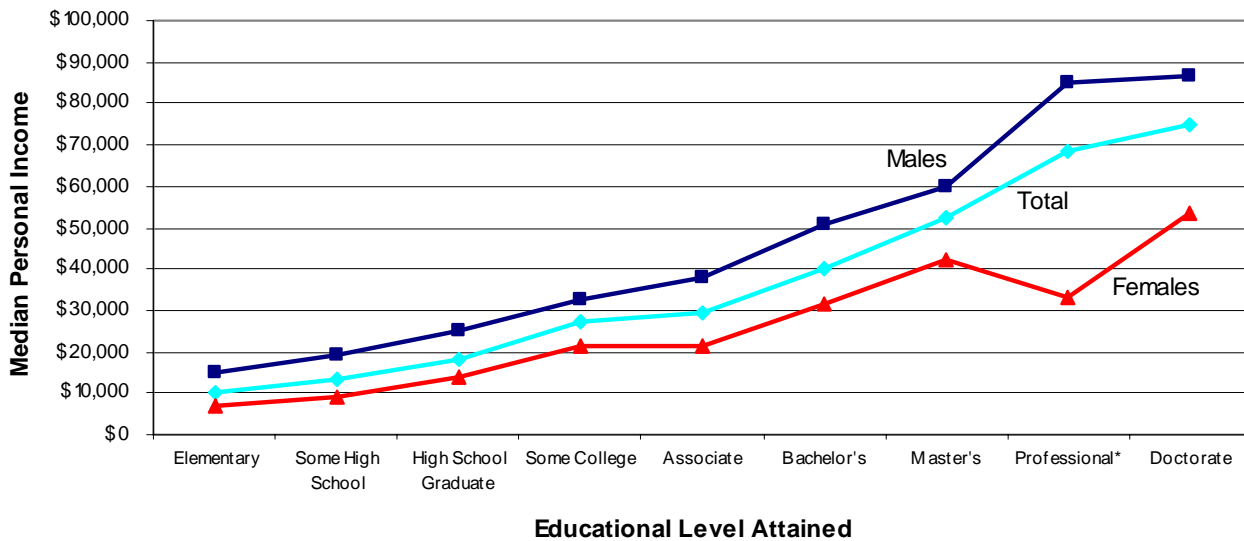

Figure 10. Percent of Persons (25+) with a BA/BS or Higher by Age and Sex

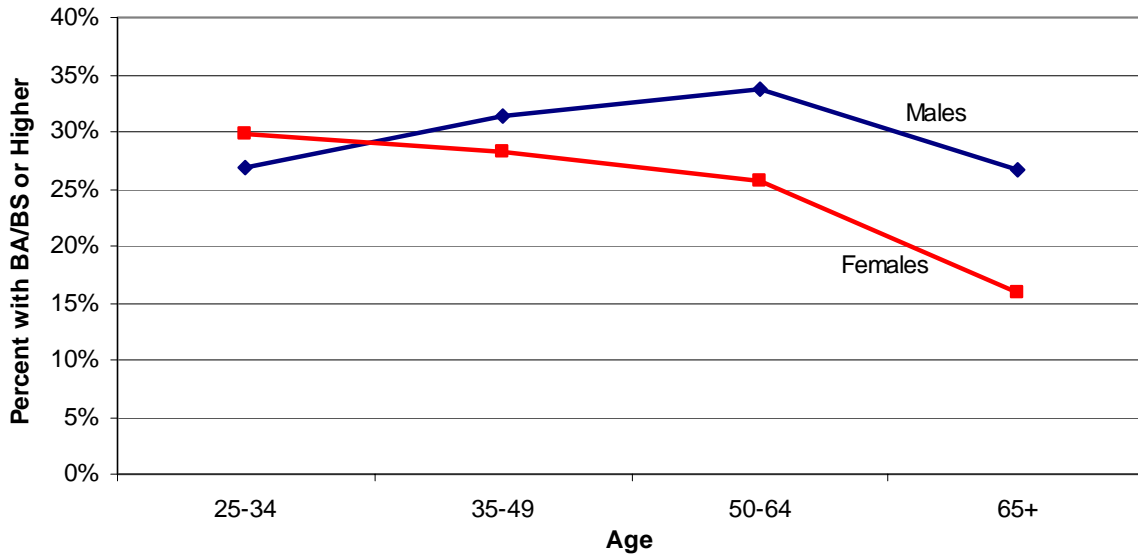

V. Persons — Foreign-Born

One in four residents of California were born abroad, reflecting the state's position as a popular destination for immigrants. Mexico accounts for 45.2 percent of the foreign-born in California but only 26.3 percent of the naturalized foreign-born. The number of foreign-born females slightly outnumbers that of foreign-born males. Persons age 18-49 represent 65.9 percent of the state's foreign-born population. Hispanics comprise the largest proportion of the foreign-born in California followed by Asians/Pacific Islanders.

Figure 11. Percent of Persons (Foreign-Born) Naturalized by Leading Countries of Birth

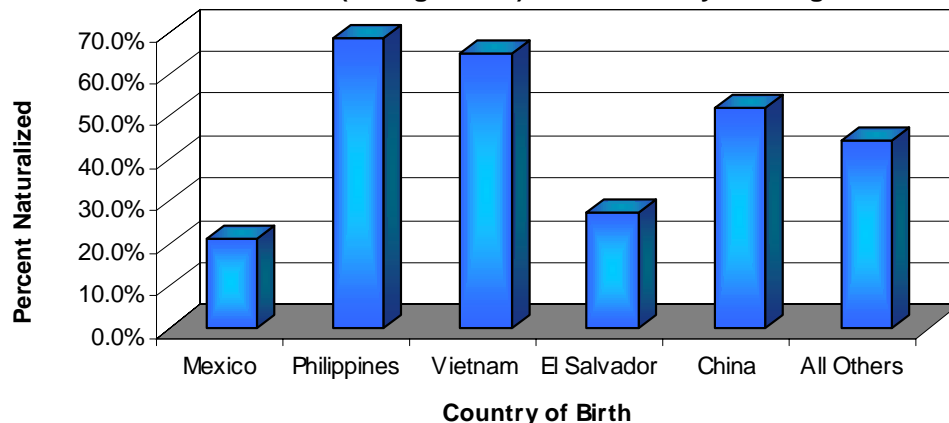

Figure 12. Distribution of Persons (Foreign-Born) by Age and Sex

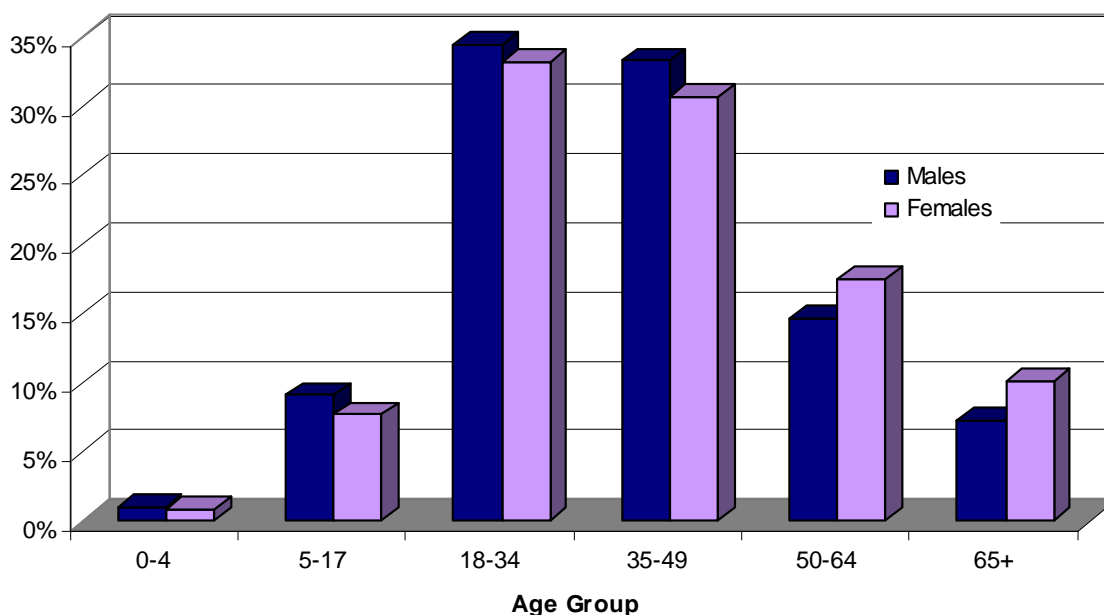

VI. Persons — Mobility

According to CPS estimates, a greater number of persons annually leave California for other states than enter California from another state. While these estimates are not consistent with other sources of domestic migration, the outward migration trend suggested by CPS data has been consistent. The CPS also found that 15.8 percent of all persons age 1 or older had lived in their current residence less than one year and that nearly two-thirds of those who moved stayed in the same county.

Figure 13. Labor Force Participation Rate for Persons (16+) by Age and Sex

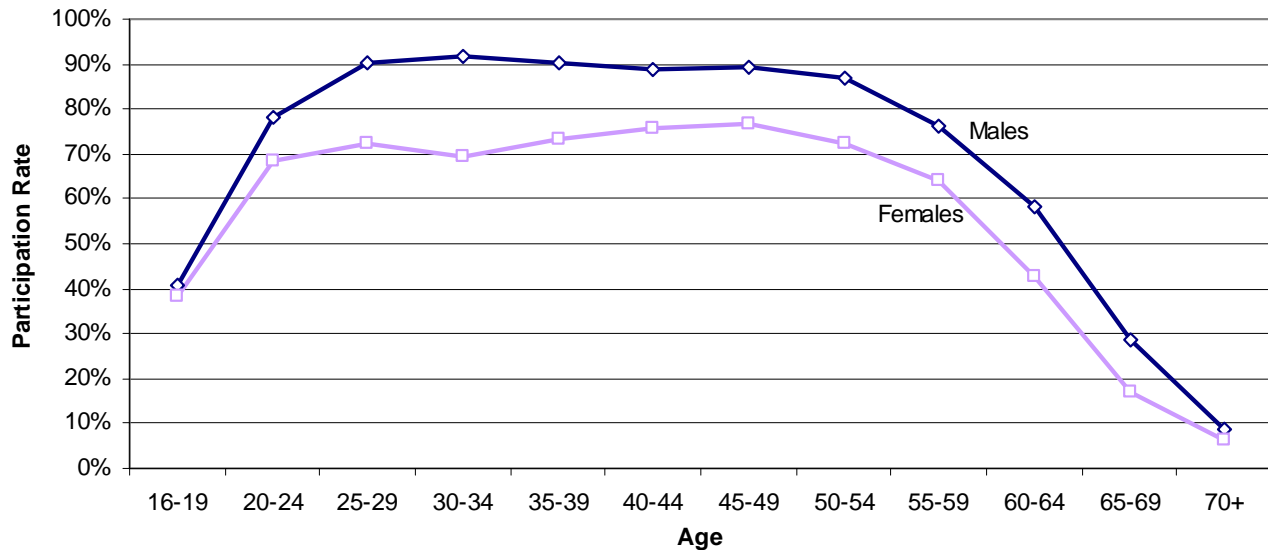

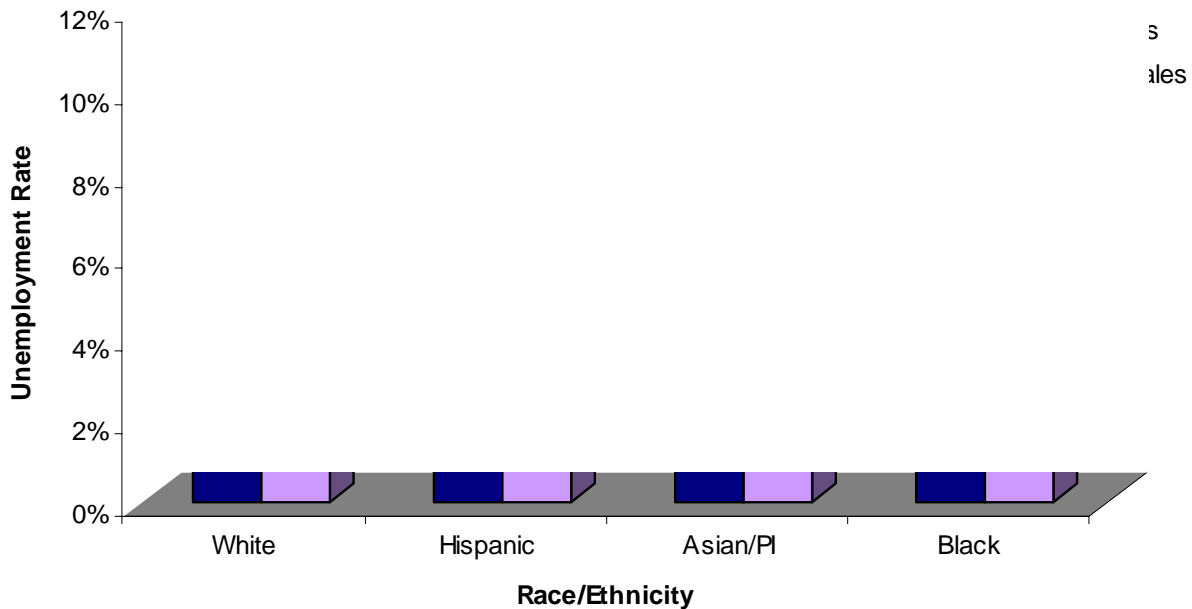

Figure 15. Unemployment Rates by Educational Attainment

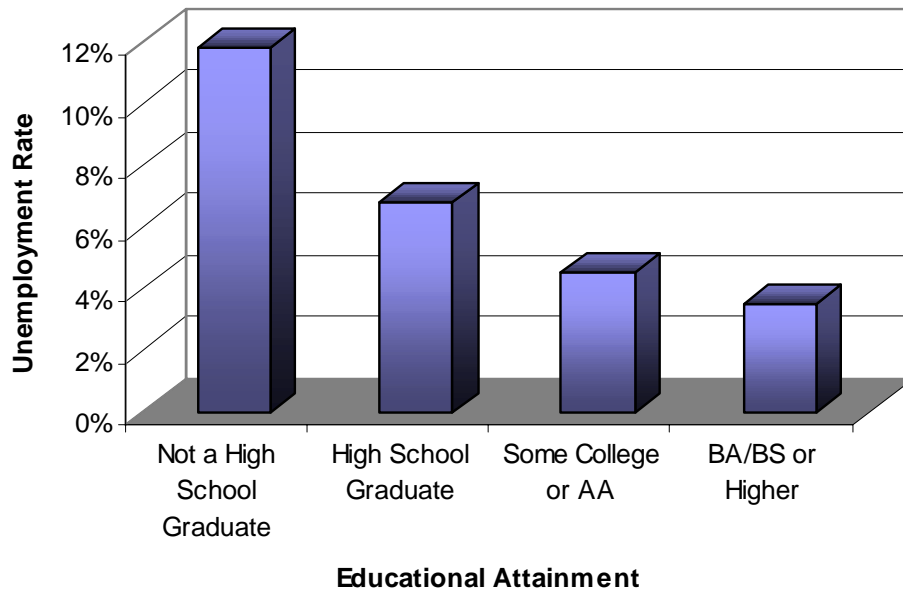

VIII. Persons — Household Characteristics

The average household size varies by race/ethnic group, from a high of 4.0 for Hispanics to a low of 2.4 for Whites. For those age 65 and older living in single-person households, 73 percent were female. The proportion of California's children living in a two-parent home was 69.4 percent. Of the 26 percent of children living in a single-parent household, about four-fifths lived with their mothers.

Figure 16. Distribution of Persons by Race/Ethnicity and Household Size

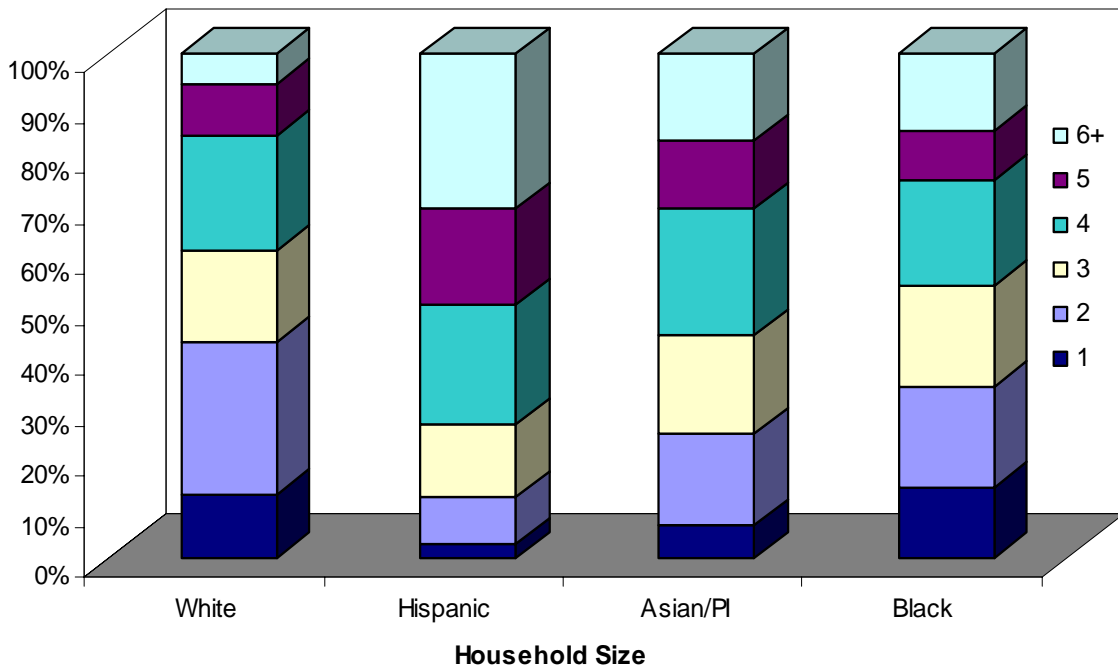

Figure 17. Distribution of Households and Persons by Household Size

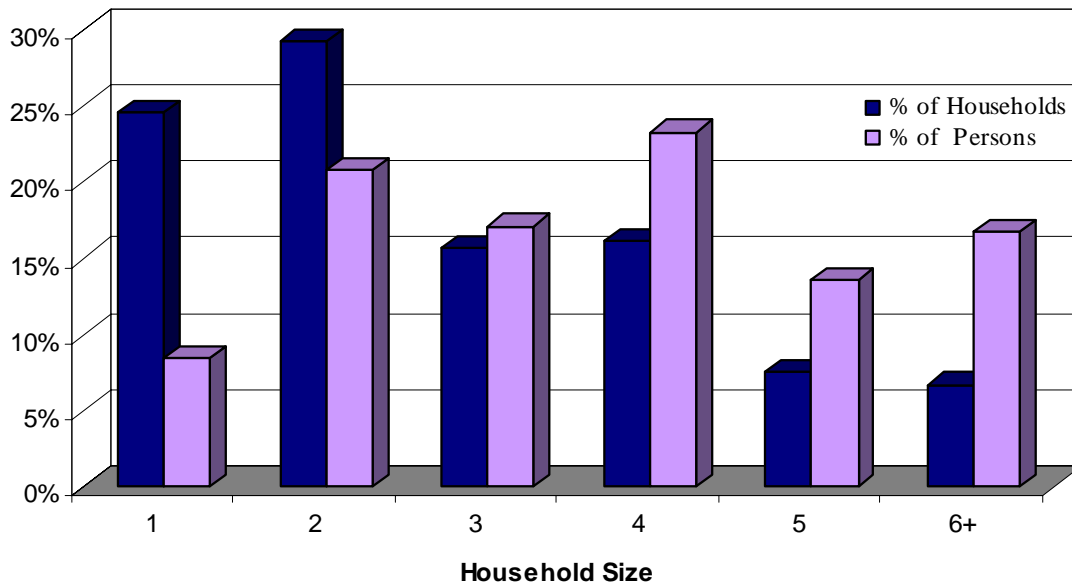

Figure 18. Distribution of Households by Household Size and Housing Tenure

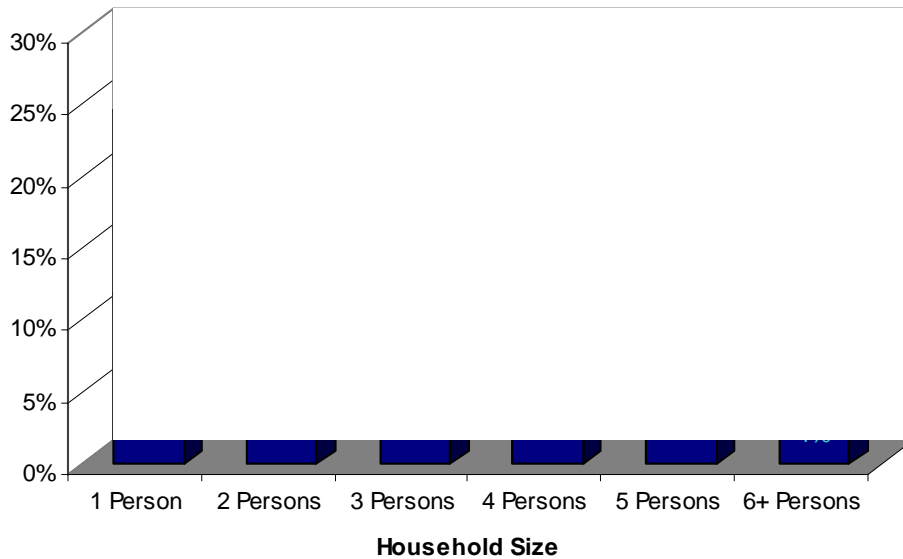

X. Households and Families — Economic Characteristics

Poverty rates were highest for female-headed households (21.1 percent) and lowest for married-couple families (6.1 percent). For families with children living below poverty level, the highest proportion (45.6 percent) were households headed by females and no spouse present. Median income was highest for White families at \$66,000 and lowest, \$37,500, for Hispanics. Median household income was highest for householders age 45 to 54 (\$59,000) and lowest for householders age 65 and over (\$24,800). Median family income increased as family size increased up to four-person families and then started to decline for families of five or more persons.

Figure 19. Distribution of Family Types with Children by Poverty Status

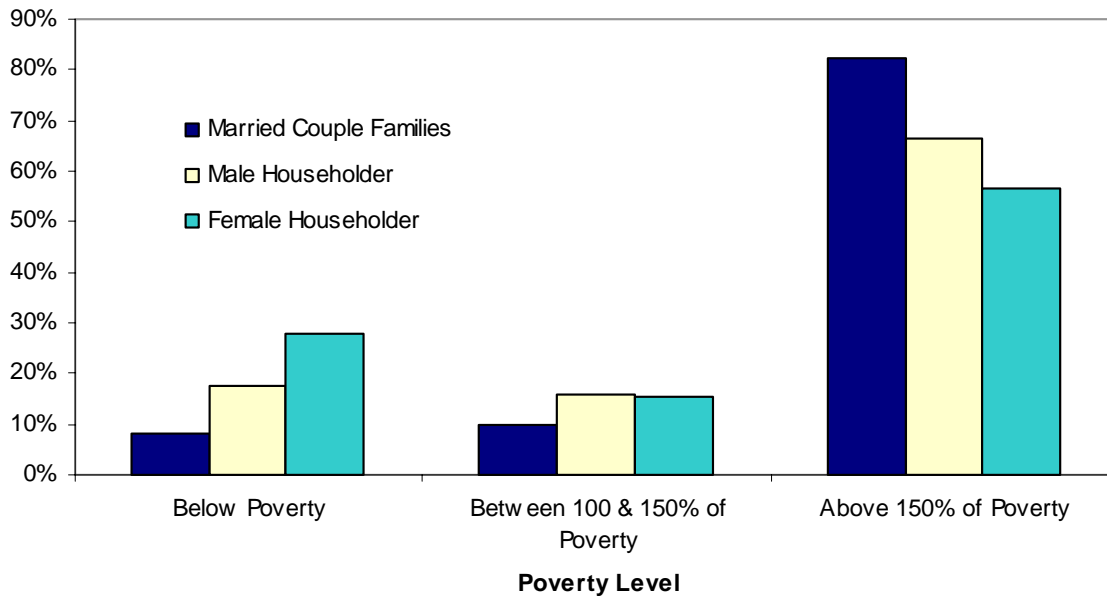


Figure 20. Distribution of Families in Poverty with Children by Family Type

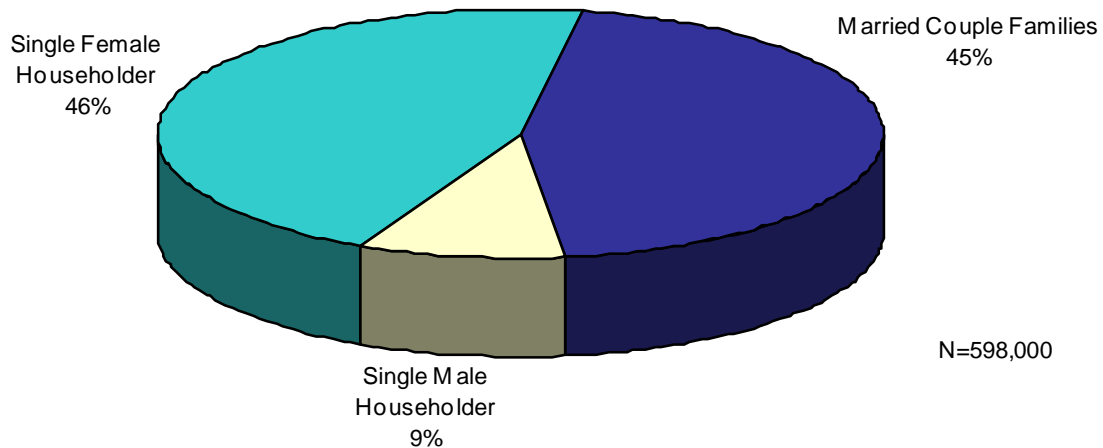

Figure 21. Median Family Income by Race/Ethnicity of Householder

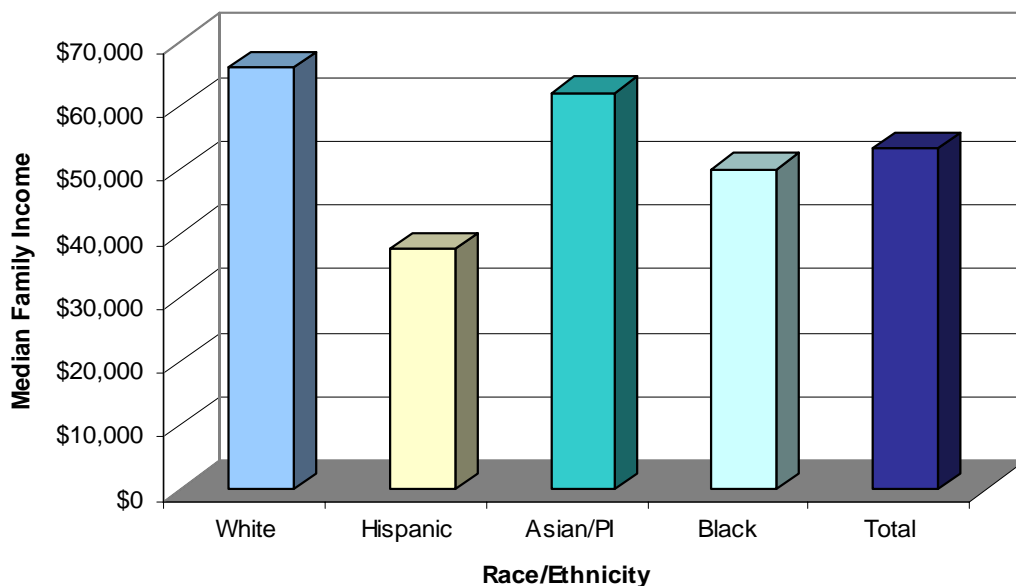

Figure 22. Median Household Income (2001) by Age of Householder

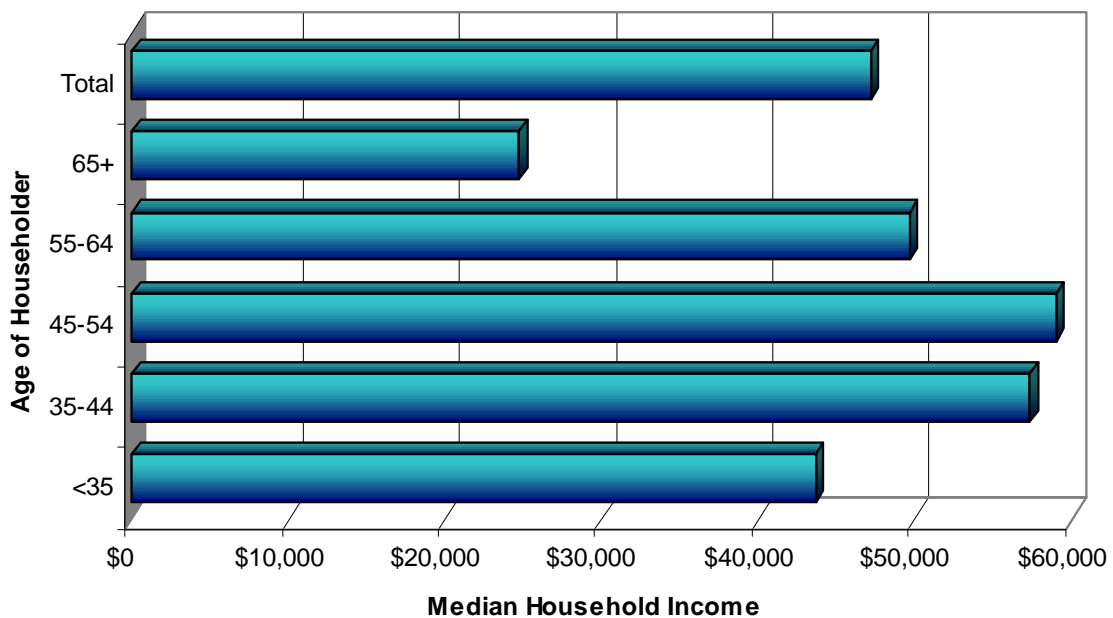

Appendix B: Major Changes in the Current Population Survey since 1985

2002: The 2002 CPS Annual Demographic File (ADF) contains the expanded sample of state estimates of children's health insurance coverage that was implemented in 2001. The expanded sample accounts for the addition of about 34,500 households nationwide and 1,231 households for California in 2002. The 2002 ADF also used weights based on Census 2000 population controls, instead of 1990 population controls used in previous years. Using 2000 based weights affects weighted frequencies, which are noticeable when comparing 2002 to earlier years.

2001: The Census Bureau will expand the sample size to improve state estimates of children's health insurance coverage in the winter of 2001-02. This data is to be released in autumn of 2002. The original September 2001 sample file was revised due to a weight adjustment.* This report contains only data from the original revised sample file released December 2001.

1996: The sample size taken in Los Angeles County was significantly reduced. The March survey for the first time contained a question on self-reported health status of the respondents.

1994: The independent national population controls used for age, sex, race, and Hispanic origin were prepared by projecting forward the population as enumerated in the 1990 decennial census adjusted for the 1990 census undercount. Most estimates in the profile were affected by these changes.

1990: The sample reduction from 1989 was restored.

1989: The sample size for California was reduced by approximately 38 percent.

1985: Controls for the Hispanic population were introduced for the first time. These controls included an estimate of illegal immigrants.
